

## **CANCELLATION & REFUND POLICY**

## Introduction

Kinetics Health Education LLC. understands that plans can change unexpectedly, and we want to provide clear and transparent guidelines for cancellations. Our cancellation policy is designed to be fair and reasonable for both our valued learners and our business. It outlines the procedures and conditions related to canceling reservations, bookings, or services with us. ## **Policy**

- 1. In the event of a <u>definite</u> seminar cancellation due to Kinetics Health Education LLC. liability, all participants will receive relevant email communication and the paid fees will be fully refunded.
- 2. Cancellation of participation due to the participant's liability is communicated only by email and the below terms will apply:
  - Up to 30 days before the start of the seminar, 50% of the amount paid will be refunded (within 2 months after seminar's completion).
  - Up to 15 days before the start of the seminar, 25% of the amount paid will be refunded (within 2 months after seminar's completion).
  - Up to 7 days before the start of the seminar, no amount will be refunded by Kinetics Health Education LLC.
- 3. Kinetics Health Education LLC reserves the right to change the date of seminars if the minimum number of participants is not met, in the event of adverse weather conditions or any event beyond the reasonable control of the organizers, that hinders the execution of part or all of the seminar, informing prospective participants by phone and/or email.
