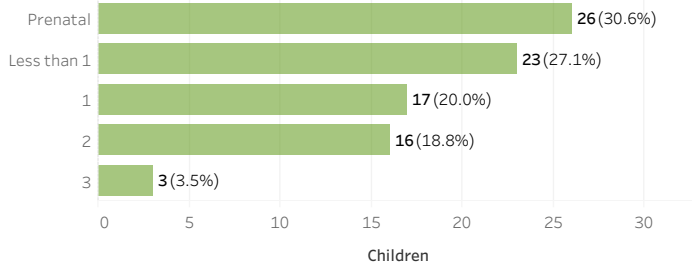

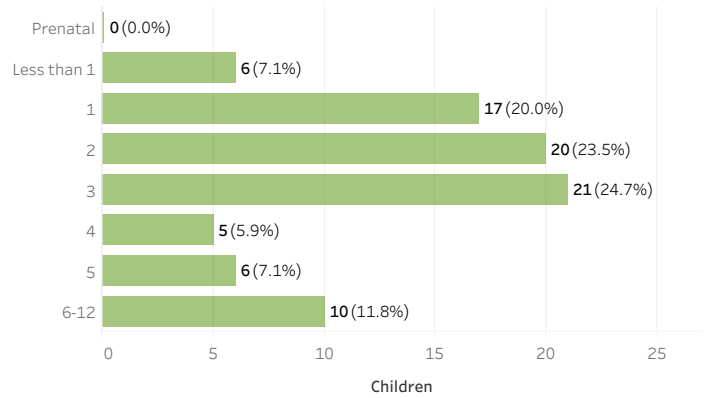

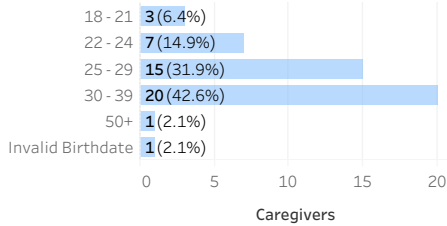

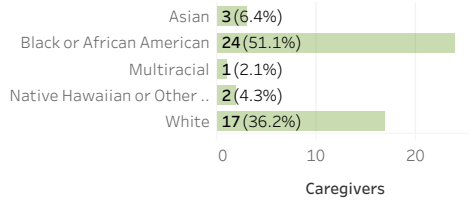

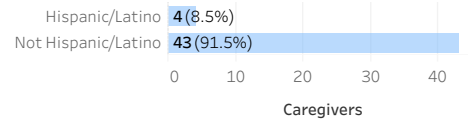
## Caregiver Age at Enrollment



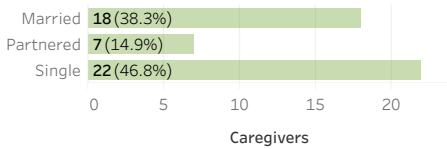
## Caregiver Race



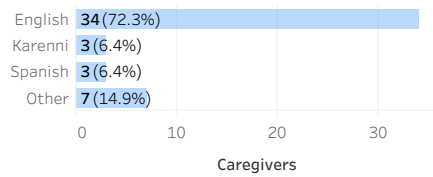
## Caregiver Ethnicity



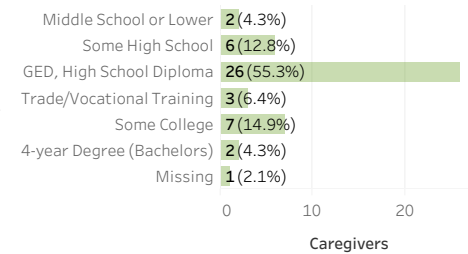
## Caregiver Marital Status at Enrollment

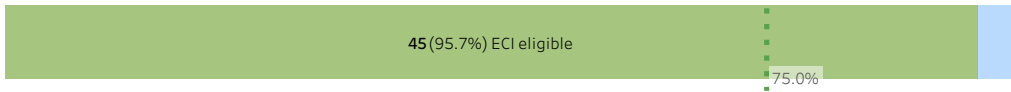

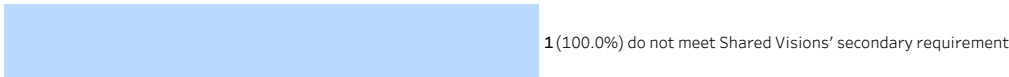
## ECI eligibility of families at enrollment

- 1) Income  $\leq$  200% of the FPL,
- 2) A caregiver with  $\leq$  a high school education, and/or
- 3) Child(ren) 0-5 who has an IFSP or IEP.

## Shared Visions' secondary requirement

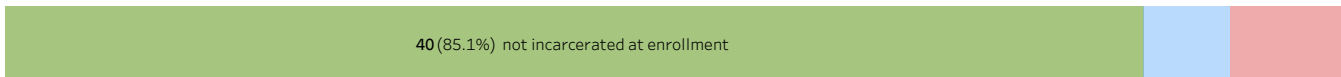

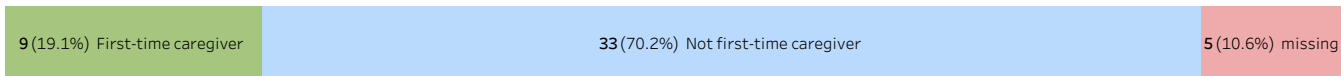
## Caregivers enrolled prenatally

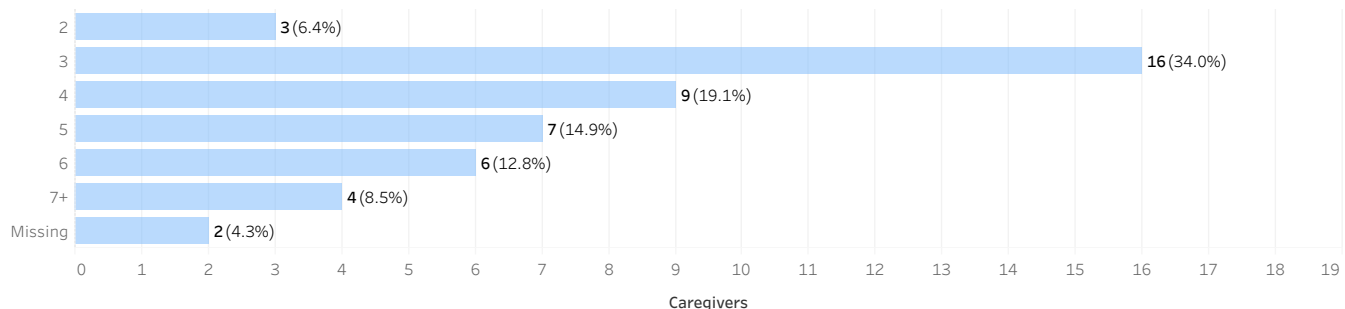

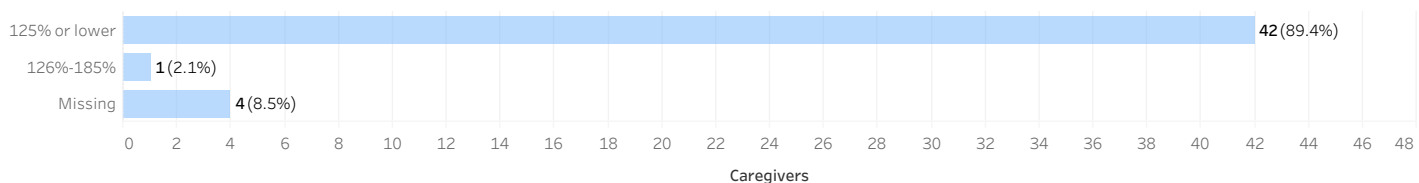
