



# Continuity coaching agreement

## CONTINUITY COACHING AGREEMENT

This Continuity Coaching Agreement ("Agreement") is entered into between The Wandering Coach Limited, ("Coach"), and the participant, as per the signatures outlined below and is also effective as of the date signed below.

### 1. SERVICES

Coach agrees to provide continuity coaching services to Client for a minimum of three (3) months unless canceled with a minimum of 30 days' notice.

Services include one (1) coaching session per month, up to ~~60 minutes per session~~, and access to Coach on a weekly basis during business hours. Client shall also have access to any books or resources created by Coach during the term of this Agreement for personal use only.

Please note that no results are guaranteed as transformation is created by you, the client. The coach acts as a support and accountability partner with the aim to guide you towards the transformation you seek. Transformation is subjective to each individual and therefore results may vary. Turning up each session and committing to any agreed actions will mean that transformation is more likely than not.

### 1. PAYMENT

Client agrees to pay Coach the sum of [£100 or 127 USD] per month, due on the [date outlined via your paypal arrangement] on the same date each month.

The client shall make payments via paypal/debit card and the payment link is on the website under continuity coaching.

Payments not received within ten (10) days of the due date will be considered late and any agreed coaching services may be subject to cancellation. You may also be charged late payment fees and this may be at the Coach's discretion.

### 2. CANCELLATION

The client may cancel this Agreement at any time, with written notice provided to Coach at least thirty (30) days prior to the next billing cycle. Coach reserves the right to terminate this Agreement immediately if Client violates any terms of this Agreement.

It is the client's responsibility to stop paypal payments from their end or notify their bank once Wandering Coach limited has been notified of the cancellation.

### 3. EXPECTATIONS

During the duration of this contract please continue to communicate effectively and regularly with your coach. Be punctual and arrive promptly to sessions to ensure that you maximize each session. Try to be as open and honest as possible each time and if you cannot attend a session for whatever reason, please aim to give us 24 hours' notice. We will make one attempt to rearrange a session and if still unattended it may count as a used session.

### 1. CONFIDENTIALITY

Coach agrees to keep all information shared by Client confidential, except as required by law. Client acknowledges that coaching is not a substitute for professional advice and is solely for personal and professional development.

### 2. LIMITATION OF LIABILITY

Client agrees that Coach is not liable for any direct, indirect, or consequential damages resulting from the coaching services provided under this Agreement. Client assumes all responsibility for their decisions and actions resulting from the coaching services.

### 3. ENTIRE AGREEMENT

This Agreement contains the entire understanding between the parties and supersedes all prior negotiations, understandings, and agreements between the parties.

### 4. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the state of the United Kingdom.

### SAFEGUARDING

Please be mindful that as Coaches and as a business we have an obligation to safeguard any participants undertaking our programs. If you are experiencing safeguarding concerns please notify a representative of The Wandering Coach Limited immediately so that we can decide whether to notify the relevant authorities.
