The following were issues reviewed at the March 25 NISP update meeting.

- 1. The independent evaluation of the Healthy Rivers proposal of Save the Poudre is proceeding with a meeting with Ed Harvey, formerly of BBC.
- 2. The Larimer County Commission briefing went well. Jeff Drager, project manager, described the status of Chimney Hollow Reservoir to new commissioners Tom Donnelly and Steve Johnson. Questions related to NISP were also addressed.
- 3. After the Fort Collins municipal elections are decided on April 7, breakfasts and other meetings will be set up with Fort Collins business leaders. John Knezovich will assist.
- 4. The last three letters from NISP participants are being acquired. Dacono is in, Fort Lupton is underway. Fort Collins-Loveland will be acquired.
- 5. A strategy to receive an endorsement from all the newspapers in the NISP area has been set (6 are in, 9 to go, plus 2nd papers in Berthoud and Windsor). A draft letter is prepared. Assignments to follow-up will be made.

Letter to Chamber for NISP Endorsement

Dear Chamber President,

The Northern Integrated Supply Project (NISP) is moving forward and its participants are strongly committed to the project's completion. We are hopeful that your chamber will endorse the project.

As you know, the project is undergoing an extensive environmental review by the U.S. Army Corp of Engineers, which should be completed in 2010. We remain confident that the project will receive the requested permit and move into its construction phase. That confidence has been reinforced by recent independent studies conducted by Black and Veatch, consultants who have determine that any perceived water quality problems can be easily addressed.

NISP is not only essential to the region's future – its economy, quality of life and agricultural sustainability – but will be a major economic development project for Northern Colorado, representing the area's largest construction project since the Colorado-Big Thompson.

We know the project has strong public support, but it also has a cadre of vocal critics. It is important to continue to build the base of support through the endorsement of the region's economic development and business leaders, and to encourage the government agencies involved to conduct their studies in an expeditious and fair-minded manner.

Your Chamber's endorsement will assist in that effort. Enclosed is a draft resolution of support, which can be used as a template. I will contact you to see when we can schedule a meeting. If you have any questions, please feel free to contact me.
