- THAT I POSSESS A VALID DRIVING LICENCE WHICH PERMITS ME TO DRIVE A MOTOR VEHICLE IN MALTA, WITHOUT RESTRICTIONS OR CONDITIONS, OTHER THAN THOSE APPLICABLE TO ALL DRIVERS LICENCE HOLDERS IN MALTA.
- THAT I AM FULLY AWARE OF THE RISKS TO PROPERTY AND TO PERSONS INCLUDING BODILY HARM, INJURY OR DEATH WHICH MY COMPETING IN THE EVENT MAY GIVE RISE TO BOTH TO MYSELF AS WELL AS TO THIRD PARTIES.
- THAT I AM FULLY AWARE THAT THE ICC IS THE ORGANISER OF THE EVENT AND THAT IT DECLINES ANY RESPONSIBILITY FOR PARTICIPANTS, SPECTATORS, SPONSORS, RACE OFFICIALS OR CONTRACTORS.
- THAT I AM FULLY AWARE THAT THE ICC MAY RESCHEDULE, POSTPONE, OR CANCEL THE EVENT FOR ANY REASON.
- IN CONSIDERATION OF THE ICC'S ACCEPTANCE OF MY APPLICATION TO PARTICIPATE IN THE EVENT AND OF MY BEING PERMITTED TO PARTICIPATE IN THE EVENT, I AM HEREBY HOLDING THE ICC AS WELL AS ITS' COMMITTEE, OFFICERS, RACE OFFICIALS, MEMBERS, CONTRACTORS AND ANY OTHER PERSONS ,BODIES OR REPRESENTATIVE AS APPOINTED BY THE SAME ICC IN CONNECTION WITH THIS EVENT, HARMLESS AGAINST ALL CLAIMS, COSTS, ACTIONS ARISING FROM ANY ACT OR OMISSION WHICH MAY RESULT IN DAMAGE TO PROPERTY, PERSONAL INJURY OR DEATH TO THE PROPERTY OR PERSON OF ANY THIRD PARTY OR MYSELF OR MY MECHANIC(S) OR ASSOCIATED PERSONNEL I ALSO UNDERTAKE TO INDEMNIFY THE ICC AS WELL AS ITS' COMMITTEE, OFFICERS, RACE OFFICIALS, MEMBERS CONTRACTORS AND ANY OTHER PERSONS ,BODIES OR REPRESENTATIVE AS APPOINTED BY THE SAME ICC IN CONNECTION WITH THIS EVENT, AGAINST ALL LOSSES, CLAIMS AND ACTIONS WHICH MAY BE TAKEN AGAINST ALL OR ANY OF THEM ARISING OUT OF ANY ACT OR OMISSION OF MYSELF, MY MECHANIC(S) OR ASSOCIATED PERSONNEL WHICH MAY RESULT IN DAMAGE TO PROPERTY, PERSONAL INJURY OR DEATH TO THE PROPERTY OR PERSON OF ANY OF THEM OR ANY THIRD PARTY.
- IT IS EXPRESSLY STATED THAT THIS INDEMNITY FORM AND ITS CONTENTS ARE NOT APPLICABLE TO THE INSURANCE COMPANY WHICH INSURES THE EVENT.
