**Subject: Discontinuation of U-S Safety Trolley products**

## **Summary:**

Due to several factors, including market changes and supply chain challenges, Starline has made the difficult decision to discontinue the U-S Safety Trolley (USST) product line. USST products have long been a vital part of the Starline (and Universal Electric Corporation) business, with Span-Guard being the longest running product line. We are extremely appreciative of our customers that have supported this business and have helped us make it successful for so long. Details regarding implementation of the discontinuation plan are found below.

#### **Products Affected:**

- Span-Guard
- Tri-Bar & Four-Bar
- TightWire & PowerGlide

#### Timeline:

- Discontinuation of sales & production of these products will be effective as of 12/31/21.
  System orders will be accepted for Span-Guard, Tri-Bar, and Four-Bar until this date, and are dependent on component availability.
- Starline will continue to offer replacement parts for Span-Guard and Tri-Bar/Four-Bar systems through 2022. Main systems components (i.e., conductors, insulation cover, housing, etc) will be offered while supplies last.
