Police Chief Previte said we will treat this like the Jazz Festival event and told Simonson to contact him and they will go over the safety and operations plan.

Treasurer Longwell reminded Simonson the organization responsibilities for hosting this event will be applying for the DOT permit for the street closing and the Village Clerk's office will get insurance from our insurance company.

Law Counsel Leone said due to liability the Village Clerk's office will not be providing eclipse glasses.
