Williston Rifle & Pistol Club By-Laws

Updated January 01, 2021

Article I – Name

The name of this organization shall be *Williston Rifle & Pistol Club*.

Article II – Objective/Mission Statement

The objective of this organization shall be the encouragement of organized rifle and pistol shooting among citizens of these United States to promote hunter education, safe handling and use of firearms, and to improve marksmanship skills. It should be considered the duty of all members to non-coercively inform and educate non-members of the advantages to be gained through membership of this club. Williston Rifle & Pistol Club is a non-profit social organization/club.

Article III – Membership

Any citizen of these United States may become a member of this organization on vote of the Executive Committee. Applicants must be able to legally own a firearm. Applicants must submit a completed membership application and appropriate fee at a regular club meeting. The application may be made in person or through a member who is in good standing. Membership shall not be discriminatory based on age, sex, race, or religion.

A) Types of Membership

There shall be three types of membership. They are defined as:

1. Individual Membership
2. Family Membership – Principle member including spouse/significant other and minor children as well as any children enrolled in college living in the same domicile.
 - Family members under the age of 18 will be allowed access to the club only under direct supervision of the principle member, guardian, or other adult club members.
3. Junior Sponsored Membership – Minor children under the age of 18 may become a junior sponsored member.
 - Junior sponsored members must have a consent form signed by parent/guardian(s) and the sponsoring member.
 - Junior sponsored members must be directly supervised by the sponsoring adult member.

B) Rights of Membership

Each Member will be entitled to the use of the club range and facilities as such times and subject to such conditions as established by the Executive Committee or by majority vote of the general partnership.

Principle member and spouse will be allowed full access to the club, voting rights, and the opportunity to serve as a club officer.

C) Obligation of Membership

Members are expected to attend at least 2 of the 12 regular monthly meetings and to assist with club activities during the period of their membership. All Members including officers of the organization shall adhere to the following:

- 1) Obey all posted club rules
- 2) Obey all direction of Range Safety Officer(s)
- 3) Recognize and follow all firearm safety standards
- 4) Club members shall not engage in criminal behavior including
 - Theft of club property
 - Vandalism/destruction of club property
 - All damage shall promptly be reported to a member of the Executive Committee
- 5) Members shall not engage in any behavior that could bring the club into disrepute

Members with access cards who violate the above obligations will be subject to disciplinary action up to and including revocation of access cards and/or membership without refund by the Executive Committee.

Members who disregard membership obligations are subject to Article IX of the club by-laws.

Article IV – Dues

Annual membership dues shall be due and payable not later than January 1st of each year. Due levels shall be determined by vote of the Executive Committee. No member in arrears after February 15th shall be entitled to vote or to any privilege or benefit of membership.

Dues will be determined annually by the Executive Committee

Article V – Access Cards

Access cards will be available for an annual fee to paid members for their personal use only. The fee will follow the same prorated schedule as the annual dues.

The annual fee will be determined by the Executive Committee.

The cost of the access card can be waived for paid members based on volunteered service to the club. Revocation of access cards will occur by violators of Article III – Section C and no refund will be issued.

Article VI – Meetings

A) Annual Meetings

Annual meetings shall be held in January of each year or within a reasonable time thereafter. At which time there will be an election of officers. Officers shall remain in office until such time a successor(s) have been elected. All materials pertaining to the functioning of the club shall be surrendered to newly elected officers immediately upon their installations.

B) Regular Meetings

Regular meetings shall be held for the transaction or ordinary business shall be held monthly.

C) Special Membership Meetings

Special meeting may be called at any time by the President or a majority vote of the Executive Committee. Notice of time and place of special meeting shall be given to all officers and members no less than seven days prior to meeting.

D) Special Executive Meetings

Special meetings may be called at any time by the President or a majority vote of the Executive Committee. Notice of time and place of special meeting shall be given to all officers no less than seven days prior to meeting.

Article VII – Officers

- A) The Officers of the club shall consist of President, Vice President, Secretary, Treasurer, and at least two Directors who shall constitute the Executive Committee. Officers shall be elected biannually by a secret majority vote at the annual meeting of the club. The President, Vice-President, Secretary, and Treasurer shall hold office for a term of two years or until such time as successors are elected. The Directors shall hold office for a term of two years until such time successors are elected. The election schedule will be as follows:
- The President, Secretary and one Director shall stand for election on a biannual basis.
 - The Vice-President, Treasurer and one Director shall stand for election on a biannual basis, on alternating years.
- B) The Executive Committee shall have general supervision and control of all activities of the club and requirements of membership.
- C) Three members of the Executive Committee shall constitute a quorum.
- D) Resignation of any officer may be accepted by the majority vote of the remaining members of the committee.
- E) A vacancy in the Executive Committee may be temporarily filled by a majority vote of the remaining members of the Committee. In the event of the temporary installation of a Director, that Director must stand for election at the next annual meeting.
- F) The Executive Committee shall establish such committees deemed necessary for the operation of the club and appoint committee chairpersons.
- G) Each officer shall serve on a volunteer basis and shall not receive compensation in any manner for their work at Williston Rifle & Pistol Club.
- H) Any officer may be removed from office by a two-thirds majority vote of the members in good standing present at any special meeting called for that purpose. No vote on removal may be taken unless at least seven days prior notice has been given to the officer of the charges preferred and of the time and place of the meeting. At such special meeting the officer shall be granted a full hearing.

Article VIII – Duties of Officers

- A) The President shall preside at all meetings of the club and of the Executive Committee. The President shall be a member ex-officio of all regular and special committees, and shall perform all such other duties as usually pertain to such office.
- B) The Vice-President shall perform the duties of the President in the President's absence at the President's request.
- C) The Secretary shall conduct all official correspondence of the club, the President and the Executive Committee. The Secretary shall keep a true and accurate account of all meetings and have custody of the organization's documents and papers of account.

D) The Treasurer shall have charge of all club funds and shall be entrusted to deposit funds in such institution(s) as approved by the Executive Committee. Disbursement of funds shall only be made by signature of two members of the Executive Committee. One signature must be that of the President or Vice President. There shall be a dollar limit of \$250 that can be spent without Executive Committee approval with the exception of routine operating expenses. There shall also be a dollar limit of \$1,000 that can be spend without membership approval.

The Treasurer shall keep an accurate account of all transactions and render a detailed report with documentation at any meeting and shall present a complete financial report to the organization at the annual meeting or by the Executive Committee in the interim.

Article IX – Warning Suspension, and Expulsion

- A) Any member or officer may be warned, suspended, or expelled for:
1. Violation of club rules
 2. Disregard of directions by a Range Safety Officer
 3. Destroying club property (Vandalism)
 4. Theft of club property
 5. Violating recognized gun safety standards
 6. Any behavior that could result in criminal charges, or
 7. Any other behavior that could bring the club into disrepute
- B) Charges against any officer or member may be referred by any member in good standing. Charges shall be in writing, clearly stating the facts relied upon and accompanied by all affidavits and exhibits which are to be used in their support. Such charges shall be filed with the Secretary, Treasurer, or President. The President shall call a special meeting to hear the charges. The Secretary shall give at least seven days prior notice of the special meeting to consider the charges to the accused, the accuser, and to either the Executive Committee or to the full membership as required. The Secretary shall make available to all involved parties a true copy of all charges and supporting exhibits.
- C) Any member may be suspended or expelled from the club for any cause deemed sufficient by the Executive Committee by majority vote of the Committee present at any regular or special meeting. No vote may be taken unless at least seven days prior notice in writing has been given to the member, of the charges preferred, and of the time and place of the meeting at which such charges will be considered. At such meeting the member under charges shall be granted a full hearing. Failure to appear at such meeting shall result in suspension or expulsion.

Article X – Match Rules

All Competitions held by the club will be governed by the rules and regulations established by the Match Director being approved by the applicable association.

Article XI – Range Officers

Williston Rifle & Pistol Club shall appoint a Chief Range Officer and Range Safety Officers. Candidates for Chief Range Officer and Range Officer shall be appointed by the Executive Committee.

Article XII – Dissolution of Organization

In the event of the dissolution of the organization, the then current members of the Executive Committee shall:

- A) Pay all outstanding liabilities of the organization in full from organizational funds. In the event that such funds are not adequate to pay all the liabilities, the Executive Committee shall take whatever action is reasonable and prudent to generate those funds within the limits of the law.
- B) Decide which non-profit organization shall receive the remaining assets. Priority shall be given to a local organization of similar interests and goals to that of this organization who qualifies as a non-profit organization under 26 USC 501C, or the corresponding section of any future tax code. Failing that, the Executive Committee may direct the remaining assets to be distributed to an organization as is appropriate in keeping with the intent of this section.
- C) The Executive Committee will then take whatever actions under State and Federal law as may be necessary to legally dissolve the organization.

Under no circumstances shall any member of the Executive Committee, nor shall any member of the organization, collectively or individually, receive any distribution or payment of organizational assets of property, nor shall any assets or property of the organization insure to the benefit of the same.

Article XIII – Amendments

Any proposed amendments may be introduced by any member in good standing at any regular or special meeting called for that purpose. Notification of date, time and place of meeting and copies of proposed amendments must be sent to all members at least seven days prior to meeting. A two-thirds majority vote of members present will be required for passage of any amendment.

Range Rules

Basic Rules For Firearm Safety

- 1) Treat all firearms as if they are loaded.
- 2) Keep the muzzle pointed in a safe direction.
- 3) Keep your finger off the trigger and out of the trigger guard until you are on target and ready to fire.
- 4) Know your target and your target's surroundings.

General Range Safety Rules

- 1) **Safety** is the foremost concern of all the individuals using the range.
- 2) Eye and ear protection shall be worn at all times while on the range.
- 3) No firing from beyond the shooting benches.

Range Rules

- 1) **Cold Range.** Williston Rifle And Pistol Club operates a COLD RANGE. All firearms shall be stored in a closed case or range bag and firearms shall at all times be and remain (A) unloaded, (B) the actions open, and (C) detachable magazines removed (Rendered Safe). All exposed firearms may not contain any ammunition except when they are actively being used on a "Hot" firing line.
THERE ARE ONLY TWO EXCEPTIONS; (1) firearms properly presented on the firing line during such time the firing line is HOT (see Rule 4) and (2) firearms carried concealed (See Rule 5).
Firearms are only to be handled at the designated safe handling area. Firearms shall be rendered SAFE prior to bringing firearms to the designated SAFE area. No handling of ammunition in the designated SAFE area.
In the showing of firearms, the firearm shall be brought to the SAFE Firearm Handling Area and visually and physically verified that the firearm is rendered SAFE by both parties prior to showing, at which time the muzzle shall remain in a safe direction.
- 2) **Firing Line Generally.** The firing line may either be HOT or COLD, and it is the responsibility of the member to determine its status. The status of the firing line may be changed from COLD to HOT or from HOT to COLD by the range officer in charge or, if no range officer is present, by the expressed agreement of all persons on and around the firing line. In this regard:
 - A) No firearm shall be handled or loaded until the firing line has been declared HOT;
 - B) Unless the firearm has been rendered safe, is in a closed case or range bag, no firearm shall be removed from the range when the firing line is HOT.
 - C) No person shall go downrange or move in from of the firing line for any reason unless and until the firing line is declared COLD as provided in Rule 3 below.
- 3) **Cold Firing Line.** The following conditions must be met before any person may go downrange or move in front of the firing line:
 - A) All persons on and around the firing line have acknowledged that the firing line is COLD;
 - B) All firearms present on the firing line have been rendered SAFE;
 - C) All rifles have been placed in a rack or have an empty chamber indicator in place;
 - D) All pistols and revolvers have been placed in closed case or have an empty chamber indicator in place;
 - E) All persons not going down range have moved away from the firing line ;
 - F) No firearm shall be touched for any reason until the firing line has again been declared HOT; this means, but is not limited to, no sight adjustments, no cleaning, and no moving firearms to and from the firing line.
 - G) With respect to scheduled matches, the match director may modify the procedures set forth in this and other rules to the extent appropriate for the shooting activity involved. All such modifications shall be consistent with good safety practices and shall be subject to review the executive board and safety officers.

The firing line is not fully "COLD" until all shooters have confirmed the command of COLD range and have properly secured their firearms by unloading them, removing all ammunition, leaving the breech open, engaging the safety, placing the firearm down on the bench, and stepping away from the firearm. Empty chamber indicators should be used if available.

When a firearm is properly secured and the shooter is away from the firearm each shooter must call "Line Clear" and shooters may proceed down range.

- 4) Hot Firing Line.** When the firing line is HOT, the following requirements must be met:
- A)** Eye and ear protection is mandatory for all persons on the range.
 - B)** Firearms may be loaded and firing commenced.
 - C)** All firing shall be done from the bench. The only exception is for scheduled matches where other positions are part of the course of fire. In no event shall the muzzle of any firearm be positioned behind any other person regardless of their position.
 - D)** No loaded firearms shall be left unattended or moved from the firing position.
 - E)** All firearms which are not actually being used shall be rendered safe; only one (1) firearm may be considered used at any one time;
 - F)** All firearms shall be rendered safe before being removed from the firing line; and
 - G)** Firearms that have been rendered safe or placed in a range bag can be removed from the firing line out of the range.
- 5) Concealed and Open Carry**
- A)** Although not discouraged, concealed carry (notwithstanding any provisions of above rules to the contrary) is permitted by those members of Williston Rifle And Pistol Club possessing a North Dakota Concealed Weapon License or other valid carry license/permit recognized by the State of North Dakota. Concealed carry by guests is not permitted.
 - B)** Members who carry concealed do so subject to the condition that the carry weapon must remain in the holster worn on the body.
 - C)** Open carry by either members or guests is not permitted; and
 - D)** The host member has the responsibility of ensuring that his or her guests comply with this rule.
- 6) Cease Fire Commands.** “Cease Fire” or a similar command such as “Range COLD” shall be made by anyone present who observes an unsafe condition and such command shall be obeyed immediately by ceasing fire. Rendering safe all firearms and placing them on the bench.
- 7) Guests.** Williston Rifle And Pistol Club is a private range, for use by paid-up members, associates, and invited guests only. Guests may be brought to the range on Tuesday and Thursday open range nights, and may use the range only after a safety briefing by a board member and signing a “hold harmless agreement”.
- 8) Alcoholic Beverages/Drugs.** No alcoholic beverages of any type are permitted on range property, and no one under the influence of alcohol, drugs, or other mind altering substances shall enter range property.
- 9) Ammunition.** Ammunition velocity limited to less than 1300 fps.
- 10) Targets.** Hang targets so that the bullet will strike the designated backstop area and not damage target hangers.
- 11) Litter.** All used targets and other trash shall be removed from the firing line and placed in available trash cans or dumpsters. All brass shall be removed from the firing line. Reloadable brass not wanted shall be placed in the brass barrel. Non-reloadable brass shall be placed in the garbage cans or dumpsters. Each member shall assist in keeping the range properly clean.
- 12) Minors.** No person under the age of eighteen (18) may be on the range, whether shooting or otherwise, unless under the direct supervision of a parent or other adult acting with the parents’ express permission.
- 13) Range Access Cards.** The range access cards are for members’ use only and may not be loaned to or otherwise used by non-members. This restriction applies to spouses and other family members.
- 14) Removal For Safety Violations.** Any officer may remove anyone engaging in a dangerous practice from the range property.

This is a legally binding document, by signing this Agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for injuries to yourself or your property arising out of your use of Williston Rifle & Pistol Club now or any time in the future.

Privacy Act Statement

Personal data is solicited under authority of 10 U.S.C. 3012. The information is for use to determine eligibility for voluntary participation at Williston Rifle & Pistol Club.

In return for use of premises, and/or participation in any activity at the premises, and/or for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

I, _____, HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge the Williston Rifle & Pistol Club and its agents, managers, sponsors, employees, officers, directors, affiliates, successors, and assigns, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I ever had or may have, arising from or in any way related to my participation in any events or activities conducted by, on the premises of, or for the benefit of, Williston Rifle & Pistol Club provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct.

I understand that the activities that I will participate in are inherently dangerous, that firearms by their very nature may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. I understand that certain risks, dangers, and injuries due to inadequate or defective equipment, and all other potential dangers inherent to activities involving firearms exist. On behalf of myself, my heirs, assigns and next of kin, I waive all claims for damages, injuries and death sustained to me or my property that I may have against the aforementioned released party to such activity whether caused by the ordinary negligence of the released party or otherwise, with the exception of acts of gross negligence, or intentional, willful or wanton misconduct as indicated above.

By this Waiver, I assume any risk, and take full responsibility and waive any claims of personal injury, death, or damage to personal property associated with Williston Rifle & Pistol Club including but not limited to target shooting, using the facilities or equipment in any manner, form or fashion, and engaging in any other related activities.

This WAIVER AND RELEASE contains the entire agreement between the parties, and supersedes any prior written or oral agreements between them concerning the subject matter of this WAIVER AND RELEASE. The provisions of this WAIVER AND RELEASE may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties.

The provisions of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of Williston Rifle & Pistol Club whether by agreement, by operation of law, or otherwise.

I have read, understand and fully agree to the terms of this WAIVER AND RELEASE. I understand and confirm that by signing this WAIVER AND RELEASE I have given up considerable future legal rights. I have signed this Agreement freely,

voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intentions to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law. I am 18 years of age or older and mentally competent to enter into this waiver.

If under the age of 18, (or, if by requested by a Range Officer) my age is listed. If a minor, under the age of 18 years, I understand a parent or legal guardian's signature agreeing to this waiver is required.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all Williston Rifle & Pistol Club range rules, any separate rules or procedures required by any activity, the procedures, safety rules, and any and all Range Officer instructions, whether communicated in writing, posted on the premises and/or communicated verbally.

Initial here _____ 1. **Acknowledgement of Danger.** I acknowledge that engaging in sport shooting is dangerous. I further acknowledge that no matter what precautions I may take, including but not limited to the wearing of various types of protective gear (including hearing and eye protection), that I could experience injury of a very serious nature and/or die as a result of an accident or incident. I therefore engage in such activities voluntarily and at my own risk.

Initial Here _____ 2. **Assumption of Risks.** I acknowledge and represent that I am familiar with the significant risks and dangerous nature, including but not limited to causing death or serious bodily injury to myself and others, and causing damage(s) to property, which originated from participating and otherwise engaging in sport shooting. I hereby assume any and all responsibility and liabilities pertaining to such risks, whether to myself or to others and without limitation or qualification. There have not been any express or implied representations to you on behalf of Williston Rifle & Pistol Club except as set forth in this Agreement.

Initial Here _____ 3. **Physical and Mental Condition.** I acknowledge that at the time of signing this Agreement I am in sufficient physical and mental condition to engage in sport shooting on this range.

Initial Here _____ 4. **Condition of Equipment.** I have, prior to engaging in any sport shooting at Williston Rifle & Pistol Club, determined that, by professional standards, my shooting equipment, ammunition, and all corresponding items are in good condition and suitable for the shooting contemplated by this Agreement.

Initial Here _____ 5. **Comprehensive Release.** I do hereby, on behalf of myself and my heirs executors, administrators, assigns and legal representatives, unconditionally and irrevocably release and discharge Williston Rifle & Pistol Club, Williston Rifle & Pistol Club's successors, assigns, owners, shareholders, directors, officers, employees, agents, representatives, attorneys, independent contractors, subsidiaries, and affiliates and each, every and all persons acting by, though, under or in concert with any of them (collectively, "Released Parties"). I further do hereby on behalf of myself and my heirs, executors, administrators, assigns and legal and personal representatives agree not to sue, or otherwise initiate legal, equitable or similar action or to otherwise file a complaint or other action for controversy resolution or otherwise seek losses, costs or expenses of any nature whatsoever, known or unknown, suspected or unsuspected, fixed or contingent, including without limitation, wrongful death, and any and all personal injuries to third parties, and injuries to property, real or personal, known or unknown, against any of the Released Parties, caused by any reason whatsoever related to Williston Rifle & Pistol Club and my sport shooting on or about Williston Rifle & Pistol Club's premises and/or facilities. This Release shall pertain to any claims which were known or unknown, anticipated or unanticipated at the time of the execution of this Agreement, including any information of any nature which, if known by me on the date of execution of this Agreement, may have materially affected by decision to execute this Agreement and specifically this Release.

Initial Here _____ 6. **Indemnity.** I hereby indemnify, without qualification or limitation, the Released Parties and defend and hold the Released Parties harmless from and against any and all claims, causes of action, demands or charges of every kind and nature, which any third part or person may claim to have or to hold for property damage or personal injuries or any other damages including death, arising from any cause or reason, of every kind and nature pertaining to this Agreement originating from my relationship with any of the Released Parties and any activity directly or indirectly arising from or contemplated by this Agreement.

Where my initials appear above, I acknowledge that I have read, understood, and agreed to the provision beside those initials. In addition, my signature below indicated that I have read this entire Agreement, understand it completely, and agree to be bound by its terms.
