Medical Director's Report 9.

Dr. Yin reported:

- COVID Slight rise in COVID Nationally. In the U.P. COVID is up to 6-7 cases a week.
- Monkeypox No new cases. Currently 399 cases in Michigan.
- RSV Recommendations for people 60+ to receive the RSV vaccine in the fall.
- Blastomycosis No new cases since May, 2023.
- Swine Flu Two cases of Swine Flu in humans have been reported in Lower Michigan. One case is associated with the Oakland County Fair and one case with the Tuscola County Fair. No cases of swine flu have been reported in Delta or Menominee Counties in the past five years. Swine flu in pigs is like the common cold, including runny nose, watery eyes, depression, fever, lethargic, sneezing, shortness of breath and coughing. Swine Flu is an Influenza A virus, and can be mild and asymptomatic in pigs. Swine Flu in humans is rare and is spread by droplets. Usually, it is not severe unless the person is high-risk due to other pre-existing health conditions. In some cases, Swine Flu can mutate and can be spread more rapidly. Humans experience flu-like symptoms. Anti-viral therapy is available.

Health Officer's Report 10.

Mr. Snyder reported:

- CAHC The planning grant for The Child Adolescent Health Center at Bay College is progressing. Physical health as well as Mental health services will be provided at the clinic. The name of the clinic will be "The Center for Youth Health and Wellness." The Clinic is on track to be partially operational by January 1, 2024. A recent survey was conducted and 95% of people surveyed are in favor of
- Mobile Clinic LDV has said that the Mobile Unit will be in our possession by September 30, 2023.
- Vacancies The Health Educator position has been open for 3 months and the Clerk position was filled this week. The Personal Committee may have to look at wages December.
- Drive-Thru Flu Shot Clinics The Delta County flu clinic will be held on Saturday, September 23rd from 9:00-1:00 ET. The Menominee County flu clinic will be held Thursday, September 28th from 11:00-2:00 CT.
