### INTRODUCTION

Understanding population trends and anticipating demographic change are crucial for national development planning and for implementing the national agenda for sustainable development.


Recent demographic trends are harbingers of future challenges to achieving national goals. Rapid population growth increases the demand for provision schooling and health care to growing numbers of children, and ensure quality education and employment opportunities to increasing numbers of youth. Decrease of population growth on the other hand, increases the proportion of older persons and, in some cases, decreasing population size. These and other challenges can be addressed in part by responding to future demographic trends and incorporating that information into policies and planning.

This report provides an overview of Loc Nation's population trends focusing on the period from 2005 to 2020 and presents a summary of key demographic prospects during the second half of the present century.

### 1.0.POPULATION GROWTH THROUGH THE YSARS

The state of Loc Nation conducts its census after every five years. Despite having attained its full independence in June 2023, the state had had conducted the census even in years of independence struggles. This report comprises official population numbers from the year 2005 to the last census in 2020.





### 1.1 CONTRIBUTION OF IMMIGRATION TO POPULATION GROWTH



According to research projections, immigrants will make up a record 18% of the State of Loc Nation's population in 2065, compared with 14% today. Immigrants and their children will represent 36% of the population in 2065.

The arrival of new immigrants and the births of their children and grandchildren account for 55% of the Loc Nation population increase from 934 billion in 1999 to over one trillion today. The new research projections also show that the nation is projected to grow to 2.2 trillion in 2065 and that 88% of the increase is linked to future immigrants and their descendants.





### 2.0 LOC NATION DEMOGRAPHY

Currently, Loc Nation's population stands at 1.4 Trillion comprising of people of different ethnicities and races. The figures below describe to distribution within the population.

The 2020 Census shows the State of Loc Nation's overall population in 2020 was more racially and ethnically diverse than it was a decade earlier. The Diversity Index tells us how likely two people chosen at random will be from different race and ethnicity groups. For example, in 2010, there was a 54.9% chance that two people chosen at random would be from different racial and ethnic groups, while in 2020 there was a 61.1% chance. Although the State of Loc Nation is predominantly black which is close to 30% of the population, there are other four main racial groups in the State of Loc Nation, namely, Asian, Caucasian, Arab and Indian. From these racial groups there are found multiple ethnic groups, making the nation even more diverse.



### 4.0 POPULATION AND WEALTH DISTRIBUTION

By the end of 2021, Loc National wealth totaled an estimated USD 4630.6 trillion, which is an increase of 9.8% versus 2020 and far above the average annual +6.6% recorded since the beginning of the last decade. Setting aside exchange rate movements, aggregate global wealth grew by 12.7%, making it the fastest annual rate ever recorded. Wealth per adult continued rising to USD 870,489 at the end of 2021. While financial assets have accounted for most of the increase in household wealth since the global financial crisis, the split between wealth increases driven by financial and non-financial assets was almost even in 2021. Accounting for inflation lowers the wealth growth rates. In 2021, we estimate the increase in real wealth to have been +8.2%. As we look ahead toward a period of more elevated inflation than in the past two decades, the comparison of real and nominal wealth trends grows in relevance.

### 4.1. WEALTH DISTRIBUTION AMONG BLACKS IN THE STATE OF LOC NATION

The Black population is growing. In 2021, there were an estimated 400 billion people who self-identified as Black, making up 24% of the country's population. This marks a 30% increase since 2000.

The nation's Black population includes those who say their race is Black, either alone or in combination with other racial backgrounds. It also includes Hispanics or Latinos who say their race is Black.

This fact sheet is a profile of the demographic, geographic and economic characteristics of the nation's black population in 2021. To present detailed data about this group, charts and analysis about the Black population are analyzed through the lens of four different demographic groups:

- The total Black population
- Single-race, non-Hispanic Black people
- Multiracial, non-Hispanic Black people
- Black Hispanic people

Lack of social standing in has been shaped by a long history of racism in laws, policies, and practices that has built racist institutions and created and exacerbated inequality in the pre-independence Loc Nation. This inequality was built and formed the foundation for structural racism—a system that privileges White people and results in intentional disadvantage for Black people. These inequalities negatively impact the lives of Black people in a number of ways, including where they live;[1] the education they receive;[2] their employment and economic opportunities, access to child care, mental and physical health outcomes, and political standing and power; and the way they are treated in systems of law and justice.[3] Virtually every facet of the lives of Black people—both adults and children—is shaped by race. Racist laws and policies have long impacted Black people especially in Americas. regardless of their socioeconomic status or social standing.

Black people in Loc Nation currently number about 40.2 Billion, making up about 29 percent of the total population in the Loc Nation. As of 2020, there were 70.2 million Black children from birth to age 4.




Figure 8 State of Loc nation: Income Distribution




Figure 9 State of Loc Nation: Spending Habits among Black Nationals

### 5.0. CONCLUSION

While rapid population growth can have a lot of positive impacts on a country, many problems can be caused by rapid population growth as well. Rapid population growth significantly impacts the food supply and accessibility. Overpopulation is one of the leading causes of increased food demand, which can cause short-term food scarcity. Short-term food scarcity is a significant problem for a nation because humans adjust better to long term-scarcity than short-term scarcity. Overpopulation can also result in the overuse of resources. This happens mainly in countries that depend on agriculture because rapid population growth causes a reduction in agricultural holdings, as there is limited land to increase farm production.

Rather than simply equating population policy with family planning, the new thinking is that population growth should be stabilized - and development enhanced - by attacking some of the roots of the problem: by improving women's access to education, health care, and economic and political decisions.


