3-1-1

The City of Lansing has made it easier to get your questions answered and find the city services you need with the phone number 3-1-1. Argie Martinez, the director of the City of Lansing's 3-1-1 program, came to our October meeting and shared with us about how helpful it can be to call 3-1-1. This number acts like the front desk for the city. You can call with any question about Lansing's services and they will either answer your question or direct you to the person who can. Many needs can be addressed right there over the phone, including reporting issues with the streets or sidewalks, scheduling inspections, starting/stopping services, and more. Receptionists are available Monday-Friday from 8am to 5pm. Martinez was very enthusiastic about the way he and his team are able to help Lansing residents and he highly encourages us to call.

Hot Topic: Code Compliance

One theme that surfaces in several of the Churchill Downs community meetings is city code compliance. Particularly, the issue of neighbors not following city code in their yards, and the city not enforcing it as much as some neighbors wish they would. If you see a neighbor's yard that is not up to code and you would like them to fix it, please go talk to that neighbor about it first before reporting them to the city. Your might neighbor benefit from vour conversation with them, as not everyone is aware of the rules. Among those who are aware, some are dealing with difficult circumstances that make it challenging to keep up their yard, and your helping hand might make a world of difference to them. If you have a neighbor whose yard is repeatedly causing issues and they are unwilling to work out a solution with you, you can report the code violation here.

If you would like a refresher on how your yard space is supposed to be maintained in Lansing, here is a <u>flyer</u> with the city's guidelines for yard maintenance.

In case you didn't know:

As we anticipate some snow this winter, we want to remind you that the city requires you to clear your sidewalks within 24 hours of the end of a snowfall. If you would like more information on this ordinance, you can read an FAQ <u>here</u>.
