## 1. <u>Call Meeting to Order</u>

Ms. Moslander called the meeting to order at 5:30 p.m.

## 2. <u>Pledge of Allegiance</u>

#### 4. <u>Approval of Minutes</u>

# 5. <u>Recognition of Public</u>

Ms. Moslander asked if there were any members of the public that would like to address the Trustees. There were none.

### 6. <u>Treasurer's Report</u>

Mr. Grossi reviewed the FY 2021 Annual Report with the Board of Trustees. He discussed the impact that Covid, the employment gap, and inflation have had on the economy. They discussed the outlook for interest rates and strategized regarding Bremen Township's investment strategy.

Mr. Grossi also reviewed the Township's cash balances, expenditures, and recent matured investments.

#### 7. <u>New Business</u>

Mr. Grossi informed the Trustees that they will need to file two Statements of Economic Interests – one for their home district and one as a trustee.

Mr. Grossi informed the Trustees that the IRS Mileage rate increased to 58.5 cents in 2022.

Mr. Grossi informed the Trustees that there was an article in the Chicago Sun Times in December 2021 that stated that next year's property tax distribution may be delayed until late calendar year 2022/early calendar year 2023.

Mr. Grossi informed the Trustees that the school districts had an upcoming iVisions training in January that will allow access for employees to gather personal information from the system, increase productivity for employees who work within the system, and will increase security.
