Mr. Grossi reviewed the cash balances for each month and mentioned that the June spending was higher than years past because of changes related to the TRS Gemini update. TRS is no longer allowing Districts to enhance TRS payments from September through June, but they still want to be paid in full by June 30 of each year. So, in turn Districts had to run its July and August checks prior to June 30 to pull the necessary benefits/deductions to pay TRS.

Mr. Grossi mentioned that most funds continue to be held in short-term investments,

primarily due to current market rate conditions, as a result of the impact of the COVID-19 pandemic on the economy and near zero percent short-term interest rates.

Mr. Grossi also discussed the Statement of Expenditures as presented for the periods ending March 31, 2021, thru May 31, 2021. Mr. Grossi stated that he expects that once the month of June is finalized, the total expenses will come under the budgeted figure.
