Entries submitted without USEF Safe Sport unable to supply their Safe Sport Certificate prior to start of competition may not compete and will not be refunded.
- Copy of the USDF horse's ID registration/recording card and USEF number.
- GAIG classes require Horse USDF Lifetime Registration and USEF Annual or Lifetime Recorded. Riders must have a USDF Participating Membership and a USEF Junior Active, Senior Active or Life Membership. Owners must have a USDF Participating or Business Membership and a USEF Junior Active, Senior Active or Life Membership. **Official Ride Times:** Provisional times will be available to competitors at [www.FoxVillage.com](http://www.FoxVillage.com). Official times will be available at noon the day before the show. All change requests must be made in writing by 4:00PM the Monday prior to the show. All no-shows will be scratched from their subsequent tests.

**Refund Policy:** Cancellations prior to the closing date will be refunded less office fee. **No refunds** will be given after closing date.

**Hazardous Weather/Act of God/ Accident Policy:** Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accident or emergency. Every effort will be made to reschedule with priority given to any qualifying classes being offered. No refunds for cancellations due to hazardous weather, Acts of God, accidents, pandemics, or emergencies.

**Schedule:** Classes may not necessarily run in the order listed in the prizelist. Current management tends to schedule upper-level rides in the cooler morning times. It is the responsibility of the rider to inform the show secretary of any time conflicts as soon as possible after receiving the schedule. Management reserves the right to change officials, limit entries, combine or cancel classes, modify the schedule, modify or cancel awards and/or whatever changes are required by circumstances to the competition specifications.

**Scores:** It is the responsibility of the competitor to verify the accuracy of all scores. Scoring errors must be reported to the Show Secretary within one hour of the official posting of the scores from the last class of the show day during which the score was earned.

**Awards:** 1<sup>st</sup> through 6<sup>th</sup> ribbons awarded in each class with 3 or more entries. Division Level Champion High Point ribbon and award will be given. Reserve Champion High Point Ribbon will be awarded per division. Riders must collect their ribbons and awards at the show. Ribbons and awards will not be mailed. Classes will be split Open, Adult Amateur, Junior when entries warrant.

**Concessions** are provided at show grounds.

**Dogs:** Please leave your dogs at home. Dogs are not permitted on the show grounds.

**Cell Phones:** Use of cell phones while mounted for any reason is strictly prohibited.

**Freestyles/Music:** Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior and FEI Young Rider Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a Federation /USDF Licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. To enter an FEI Para Dressage Freestyle class, a horse/rider combination must have received a minimum score of 60% in any FEI Para Dressage test (Para Novice Test, Para Intermediate Test or Para Grand Prix Test) at the rider's classified Grade. This score may be earned at a USEF/USDF licensed Dressage Competition or FEI recognized Dressage Competition or "open" Dressage class (i.e. open to all breeds) at a

Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. All FEI Pony Rider Tests are equivalent to Second Level; all FEI Junior Tests are equivalent to Third Level; all FEI Young Rider Tests are equivalent to PSG; and the USEF Brentina Cup (Young Adult) Test and FEI Young Rider Grand Prix 16-25 Tests are equivalent to Intermediate II. For purposes of freestyle qualification, all are considered equivalent to the highest test of that level and may be used to enter a freestyle at that level or a level below. Young Horse and FEI Children Tests cannot be used for freestyle qualification at any level. Music for all freestyles preferred in digital format, if on CD must be given to show office upon check-in. It is the responsibility of the competitor, if requested, to supply the management with a sound person to run the music. Sound checks will be done on breaks prior to scheduled times.

**Opportunity Classes/Intro Tests:** Opportunity classes are intended for entry level riders. Horses and riders entered only in "Opportunity" classes and Introductory tests are exempt from USEF and USDF membership requirements, and do not have to pay non-members (Show Pass) or HID fees. Federation and drug fees do not apply. Horses entered only in these classes are still subject to and must comply with the Drugs and Medications rules and are subject to drug testing. Riders and/or horses entered in "Opportunity" classes may not cross enter into other recognized classes at the show. Participants must abide by all USEF regulations to attire, tack, and equipment for the recognized show. Reference GR821 for additional information.

**Stabling:** On premise 11' x 11' stalls with full stall doors. Please note stabling requests on entry form.

**Arenas/Footing/Warm-Up:** All tests and warm-up will be ridden in high quality footing. Competition arenas include one outdoor arena (rubber/Stone dust mix 100'x 300'). Warm-up is in the indoor (sand/rubber/fiber footing 80'x 200').

### **ATTENTION COMPETITORS**

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. Sharps Containers: Show management will provide one sharps container per 50 stabled horses, per USEF rule 1211.5. Young Horse/Dressage Sport Horse Prospect: To be shown in-hand at the walk and trot on the triangle. Halters mandatory on foals. Bridles optional on yearlings, but mandatory on all horses 2 years or older. Mares accompanying foals must wear a bridle and must be issued a separate bridle number.

Individual Breed Classes: All IBC Classes to be shown in-hand at the walk and trot on the triangle. To be scored 60% movement, 30% conformation, 10% general impression. MUST include copy of breed papers or verification of breeding to participate in ANY IBC class and any breed-specific membership cards.

- 927 HANOVERIAN – Open to any American Hanoverian Society-registered horse of any age and sex whose owner is current AHS member.
- 929 OLDENBURG/ISR – Send breed registration papers.
- 930 OLDENBURG/GOV – Horse must be registered with Horse OHBS/GOV. Send breed registration papers for eligibility.
- 931 SWEDISH WARBLOOD - Send breed registration papers
- 932 DUTCH WARBLOOD (KWPN OR KWPN-NA) – Send breed registration papers.
- 933 FRIESIAN - Send breed registration papers.
- 934 ARABIAN/HALF-ARABIAN – Horse must have AHA papers (or eligibility) for purebred, half Arabian, or Anglo Arab. Send breed registration papers.
- 935 ANDALUSIAN/LUSITANO – Open to any pure or partbred Andalusian or Lusitano, all ages. Send breed registration papers.

Under Saddle Classes: To be shown at the walk, trot, and canter, both ways of the ring. Horses entered in the following classes are not required to have shown in any in-hand or group classes 925 – 926 to be scored 30% Walk, 30% Trot, 30% Canter, and 10% General Impression.

925 Materiale for 3, 4, and 5 year old Fillies/Mares (Class may be split by horse age if entries warrant)

926 Materiale for 3, 4, and 5 year old Colts/Geldings/Stallions (Class may be split by horse age if entries warrant)

Handler Classes: Every adult amateur competitor must present a USEF Amateur Card or sign an Amateur application and pay the appropriate fee. Must provide separate Entry Form since entry is for the Handler not the horse. Limited to one entry per handler.

937 Adult Amateur Handler – To be shown in hand by an Amateur. To be judged on presentation and handling of the animal to the judge, neatness and appearance of the handler and the grooming, turnout and overall condition of the animal. This class is intended to stimulate participation in the Breeding division and does not limit that person to this class. Stallions are permitted. Individuals are only eligible to compete as amateurs from the beginning of the calendar year in which they reach age 22.

938 Youth Handler –To be shown in hand by Handlers aged 12 to 21. To be judged on presentation and handling of the animal, neatness and appearance of the handler and the grooming, turnout and overall condition of the animal. This class is intended to stimulate participation in the Breeding division and does not limit that person to this class. No stallions or colts except weanlings.

Riders/Handlers MUST provide emergency contact information on their entry form. Assistant handlers must sign separate release to participate in show. USDF Horse ID # required for all entries in the Breed Show except horses that are ONLY competing in IBC classes.

SHOW PASS FEE: Effective 12/1/2013, a non-member who wishes to participate in a USEF competition must pay a Show Pass fee in lieu of a USEF non-member fee. Eligible exhibitors are prohibited from obtaining more than one (1) Show Pass per competition year. Show pass fee must be purchased online via USEF.org Please see GR 206 for additional information.


### Motor Vehicle Statement

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**Important Entry Information Requirements:** Competitors are responsible for providing valid membership numbers for all horse, owner, rider, and trainer before the day(s) of the competition. Safe Sport Training must have been completed for USEF membership to be valid. All entries must include copies of all memberships for horse, owner, rider and trainer listed on entry form. SAFE SPORT TRAINING is required for all riders, owners and trainers within 30 days of membership. If Safe Sport Training has not been completed within 30 days of membership, entries will not be accepted until proof of completion is provided. If membership is renewed during show, Safe Sport Training must be completed within 30 days or results will be nullified. Senior members that are ineligible at the start of the show must complete Safe Sport and present their certificate prior to competing to be eligible to compete and for their points to count. The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

### IMPORTANT VACCINATION REQUIREMENTS

Jericho Equestrian Center, in compliance with GR 845 will require proof of Equine Influenza Virus and Equine Herpes Virus vaccination for all horses entering the show grounds.

### Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8<sup>th</sup> Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

**Qualifying Requirements**

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or*
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

**Membership Requirements**

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

### **USDF Statement on Animal Welfare**

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival. As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

### **USEF MEMBERSHIP STATEMENT**

**Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides.**

**A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.**

### **ATTENTION COMPETITORS**

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.
