I acknowledge and fully understand that each skater/jumper and participant will be engaging in activities that involve risk of serious injuries (including temporary or permanent), death and social and economic losses which might result from the **RELEASEES** action, inactions or negligence; also, the actions, inactions or negligence of others; the conditions of the premises or any equipment use and/or rental. Further, there may be other risks not known to the **RELEASEES** and myself not reasonably foreseeable at this time that will likewise be included in this release:

- 8. Should any provision of the Release be held invalid or unenforceable by any court of competent jurisdiction, all other provisions shall continue in full effect:

I acknowledge that there have been no representations made to me by the RELASES and I AGREE TO HOLD THE RELEASES HARMLESS for any injury or loss that I may cause to any other individual or the premise. I FURTHER AGREE TO IMDEMNIFY the above set forth RELEASES in the event of any such injury or loss for which they may be held responsible:
- 10. This release shall be in full force and effect not withstanding the fact that I may be utilizing or otherwise renting equipment or other products owned or otherwise controlled by the **RELEASEES**:
- 11. I am at least eighteen (18) years of age or am the parent/guardian of the individual named below and have the legal capacity to enter into this waiver and release.
