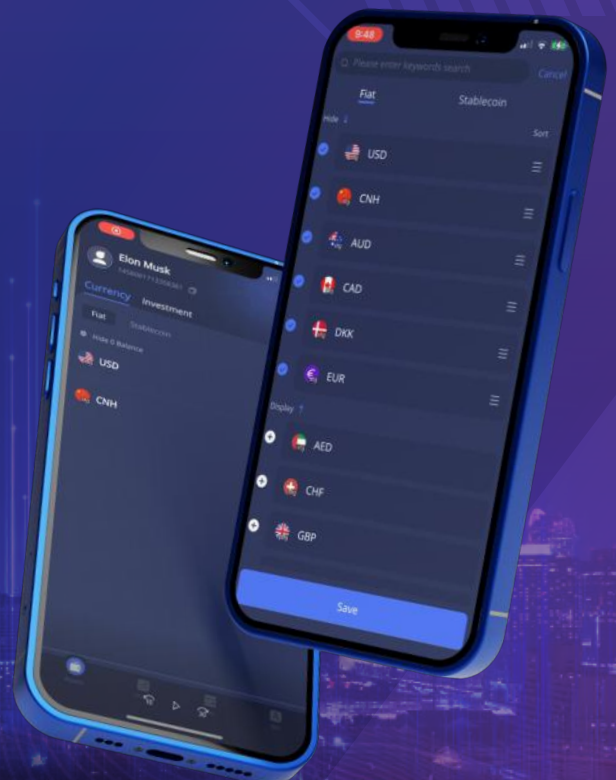

### About A-Bank

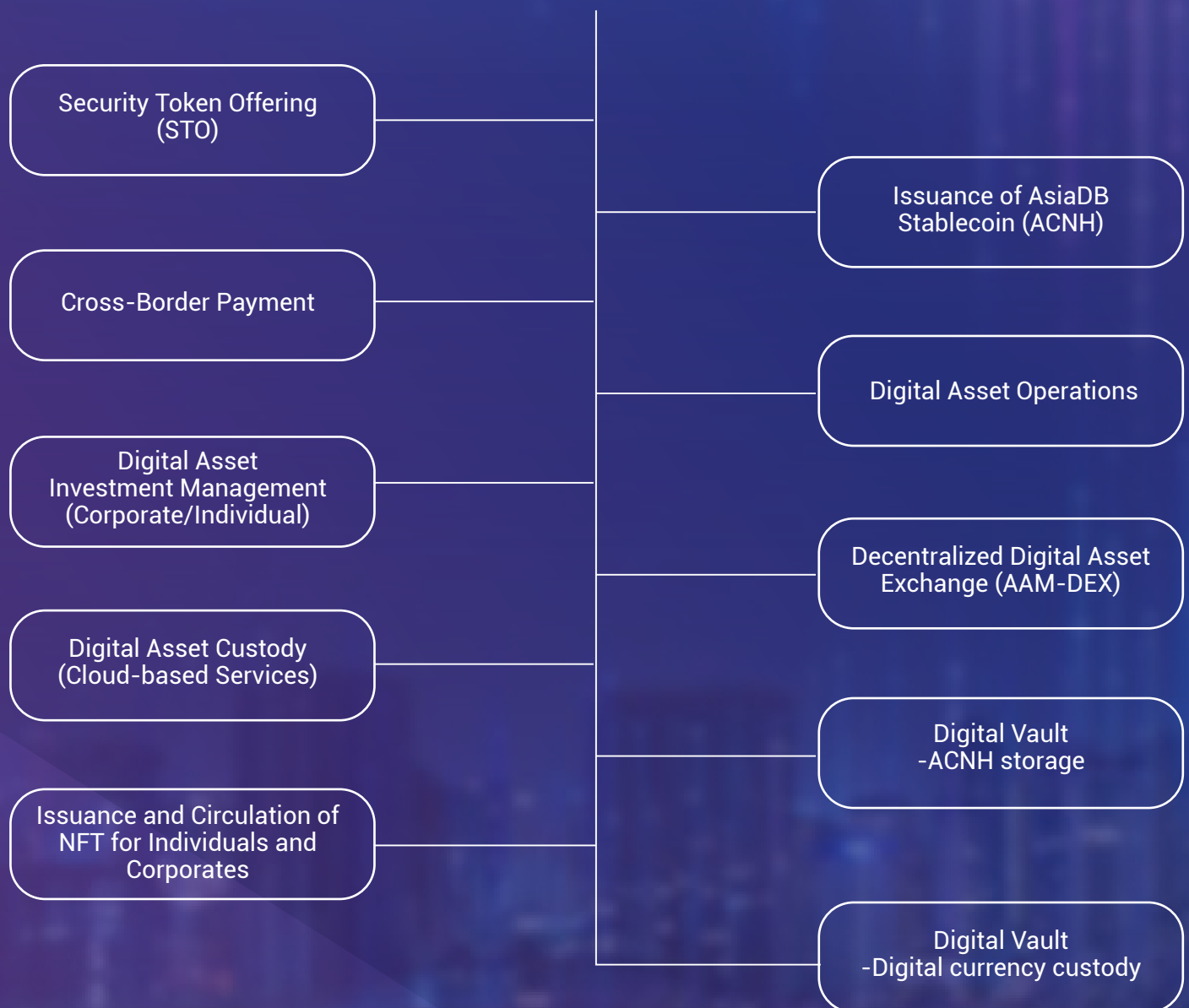
