**PURPOSE OF THE COURSE:** Provide essential end user skills to effectively use a ballistic shield in an open environment and room clearing operations. Primary focus is on individual and small team techniques and methods that provide application for patrol active shooter events and tactical team operations.

**COURSE DESCRIPTION:** A one day course on end-user core skills to use a ballistic shield as tool for high risk situations. Trainees will learn to advantages and limitations of using a shield in a practical format through realistic drills and exercises. Individual techniques are presented that include failure drills and use against unarmed resistance. Small team tactics incorporate safe and effective procedures that include post shooting arrest procedures. Training concludes with practical mini-scenarios on room clearing and hallways using shoot and no-shoot photo targets.

Instructor for this course is Ron Yanor. Ron needs no introduction as he has become the go-to instructor at MTU 13 for all things tactical. Ron brings with him a long history of training.
