The above employer shall further agree to indemnify MTU 13 in the full amount of any judgment or claim awarded to the trainee, his/her heirs, dependents and assigns for such injuries or damages sustained by said trainee during the official course of his or her temporary assignment to the training, except for gross negligence or willful, wanton or intentional misconduct.

It is further agreed that should suit or claim be filed by said trainee alleging injury or damage as a result of MTU 13's training, operations, functions, references provided and/or other activities sanctioned by MTU 13 reasonable notice of such suit or claim will be given to the department or agency employing the affected trainee; and said department or agency will appear and defend MTU 13.
