



Code of Conduct Policy

Introduction:

This Code of Conduct Policy (the "Policy") sets forth the expectations and guidelines for all individuals associated with Rushabh Foundation Charitable Trust (the "Trust") in order to promote ethical behavior, integrity, and accountability. 1. Compliance with Laws and Regulations:

- 1.2. Individuals should stay informed about relevant laws and regulations that pertain to their roles and responsibilities within the Trust.

2. Ethical Conduct:

- 2.1. Individuals must act honestly, with integrity, and in an ethical manner at all times.
- 2.2. Individuals should avoid any conflicts of interest that may compromise their objectivity or impartiality when carrying out their duties for the Trust.
- 2.3. Individuals should protect the reputation and best interests of the Trust and avoid engaging in any activities that could bring disrepute to the Trust.
- 2.4. Individuals should not accept gifts, favors, or benefits that could influence their decisionmaking or compromise their integrity.

3. Confidentiality and Data Protection:

- 3.1. Individuals must respect and maintain the confidentiality of all proprietary, sensitive, or personal information they come across in the course of their involvement with the Trust.
- 3.2. Individuals must comply with all applicable data protection laws and regulations, ensuring the proper handling, storage, and disposal of any personal data.

4. Respectful and Inclusive Environment:

- 4.1. Individuals must treat all colleagues, beneficiaries, partners, and stakeholders with respect, fairness, and dignity, regardless of their race, color, religion, gender, sexual orientation, disability, or any other characteristic.
- 4.2. Individuals should foster an inclusive environment that values diversity and promotes equal opportunities.
- 4.3. Individuals must refrain from any form of discrimination, harassment, or bullying.

- 7.2. The Trust will conduct investigations into reported violations and take appropriate action based on the findings.
