Our plastic is manufactured with a Fire Retardant Material and increased UV polymers that allow us to extend a 1-year warranty against leaks.



NO SANDBAGS OR HOLES

The material is installed without sandbags, and without adding any additional holes into the roof system.



The wrap is semi-transparent, and the system is fully vented to prevent mold growth.




RECYCLABLE

All of our wrap is 100% virgin resin material. It's a #4LDPE (low-density polyethylene) film, that is recyclable.

When multiple rolls are needed, our ground-breaking product welds together to create a continuous impermeable membrane. This also allows us to easily cut back the membrane for inspections, to later heat weld it back together, allowing any remaining warranty to stay in place. It's easy to remove and does not add any further damage to the existing roof system.
