- All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY & Cancellation Policy: BUILDINGS. Please pick-up after your dog and dispose of waste in appropriate containers on the property.
- Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

♣ Dog Aggression:

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or the trial committee.

Animal Safety:

The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements

Awards: Ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. Ribbons will be awarded for first through fourth place in Novice through Master.

Refunds:

Refunds offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
