

God's renewing power born out of faith did not just happen once 2000 years ago, but it happens today and tomorrow. Come, let us celebrate the many Easters that occur in our lives together.

## Fairhill Manor Christian Church Board Meeting Secretary Report March 13, 2024

#### We Assemble in God's Name

Moderator Gene Sheller called the meeting to order at 7:01pm by lighting the candle representing the Holy Spirit. He opened the meeting with a prayer.

#### We Celebrate our Past

The FMCC Board reviewed the submitted reports from the Senior Minister, Associate Pastor, Board Secretary, and Treasurer.

Moderator Gene Sheller asked if there were any questions regarding these reports or if there were any comments from the person submitting these reports.

A motion to accept these reports was made by Gary Ford and 2nd by Carol Daniels. The motion was carried unanimously.

#### We Present Our Offering

The FMCC Board reviewed the submitted Ministry Reports. Reports submitted were from the Trustees, Stewardship/Finance Ministry and Personnel Committee.

Moderator Gene Sheller asked if there were any questions regarding these reports or if there were any comments from the person submitting these reports.

A motion to accept the Ministry Reports was made by Linda Reese and 2nd by Brian Shaw. The motion carried unanimously.

#### **Concerns of the Past (Old Business)**

Kevin Puskarich reported on the Stained Glass Skylight Project. Options were

- 1. Do nothing
- 2. Replace with a New Continuous Barrel Vaulted Skylight
  - 3. Replace with Individual Skylights
  - 4. Replace the Existing Skylight Glazing, gaskets and hardware

Discussion followed. Chuck Riggle asked where the money would come from. The Stewardship Finance Ministry will be meeting next week to decide where the money will come from, considering the growth monies from various church investments. Pastor Gena asked the Stewardship/Finance Ministry to come back to the Board with their conclusion of where the funds will come from for the stained glass roof project.

Motion to accept the Skylight Taskforce recommendation on Option 2 to replace the barrel vaulted skylight (specifically Option 2D Slagle Roofing for \$73,000) was made by Gary Ford and 2nd by Candy Wasalasky. Motion carried unanimously.

#### **Issues of the Future (New Business)**

Brian Shaw, Treasurer, pointed out from the Treasurer's Report that we are below budget with a deficit of \$22,265.28. He noted that there is approximately \$23,500 of growth from the Parsonage Fund. That growth could be used to offset the deficit and leave the Fund intact. Motion was made to use the money

from the growth of the Parsonage Fund for the deficit by Kevin Puskarich and 2nd by Peggy Oliverio. Motion carried unanimously.

Von Lacock of the Trustees stated that they bought a new freezer and then the refrigerator went out. They plan to use the old refrigerator for storage of pots and pans. The new freezer is installed and ready to use.

Rev. Chris Stillwell highlighted upcoming Holy Week services: Maundy Thursday at 7pm at Fairhill, Good Friday Service, 1pm at First Christian and Sunrise Service, 7am at Fairhill.

Leaving in God's Name

The meeting was adjourned by Moderator Gene Sheller. Rev. Stillwell closed the meeting with a prayer.
