

RECORD RANGE RULES

RANGE 2

(12/08/2013)

- **MEMBERS ONLY.**
- GUEST(S) MUST BE WITH MEMBER AND LIABILITY WAIVER SUBMITTED BEFORE USE.
- RANGE OPEN DAILY 0700 – 2200 HOURS ONLY.
- **ALL PORTABLE TARGETS SHALL BE PLACED WITHIN 15 FEET OF DESIGNATED BULLET BACKSTOPS.**
- **NO RIFLES, SHOTGUNS OK, Law Enforcement exempted.**
- **ALL PORTABLE TARGETS SHALL BE PLACED WITHIN 15 FEET OF DESIGNATED BULLET BACKSTOPS.**
- NO CLAY, GLASS OR EXPLODING TARGETS. NO METAL TARGETS EXCEPT WITH BOARD APPROVAL.
- **DO NOT SHOOT INTO THE AIR OR GROUND.**
- SHOOTERS WILL INSURE THAT THEY HAVE AN ADEQUATE EXISTING BULLET IMPACT BACKSTOPS THAT WILL STOP AND RENDER HARMLESS, BULLETS FIRED INTO IT FROM ALL CALIBER AMMUNITION FROM ALL FIRING POSITIONS. THIS SHALL BE ACCOMPLISHED WITHOUT RICOCHETING PROJECTILES OR DEBRIS, OR STRIKING INDIVIDUALS AT THE FIRING LINE.
- **NO ALCOHOL BEVERAGES ON RANGE AT ANYTIME.**
- ANYONE WITH ALCOHOLIC BEVERAGES OR CONTROLLED SUBSTANCES IN THEIR BLOOD WILL NOT BE PERMITTED TO USE THE RANGE. PERSONS USING PRESCRIBED DRUGS ARE AN EXCEPTION, IF THEY ARE NOT IMPAIRED AND ABLE TO SAFELY HANDLE A FIREARM.
- **NO RIDICULOUS BEHAVIOR.**
- NO VEHICLES ON RANGE AT ANYTIME. *Unloading/Loading by Law Enforcement exempted*
- **NO CHILDREN ON RANGE UNLESS SUPERVISED BY A MEMBER.**
- ANYONE CAUSING DAMAGE TO RANGE EQUIPMENT OR FACILITIES SHALL BE PERSONALLY AND MONETARILY LIABLE FOR SUCH DAMAGE, THIS WILL INCLUDE THE COST OF CLEAN UP FOR FAILURE TO REMOVE TRASH OR DEBRIS.
- THE S.C.P.O.A. SHALL NOT BE RESPONSIBLE FOR PERSONAL PROPERTY OR EQUIPMENT LEFT ON THE PREMISES.
- THE USE OF INCENDIARY DEVICES, ARMOR PIERCING, AND/OR TRACER AMMUNITION IS STRICTLY PROHIBITED UNLESS OTHERWISE APPROVED BY THE BOARD.
- **EYE AND EAR PROTECTION REQUIRED.**

- PICK UP YOUR EXPENDED CASINGS.
- PICK UP AND DISPOSE OF YOUR TARGETS.
- PICK UP AND DISPOSE OF YOUR TRASH.
- ON-DUTY LAW ENFORCEMENT AGENCIES HAVE PRIORITY WITH RANGE USE.
- REPORT ANY PROBLEMS OR ISSUES TO ANY BOARD OF DIRECTOR.
- **VIOLATIONS TO SCPOA RULES MAY RESULT IN REMOVAL FROM THE RANGE AND POSSIBLE SUSPENSION FROM MEMBERSHIP.**
