#### **Old Business**

## County and City Resources for Range Maintenance/Upgrades

- City has repaired most of the recent storm damage to the rifle range access road but not very thoroughly. One of the three drainage culverts at 600 yards has been blocked by dirt moved around during repair efforts.
- County has a bull dozer but these resources cannot be used on city property without a coop agreement between city and county.
- We will put out some feelers as to the feasibility of such an agreement.
- Jim Paxon indicated he had found a supplier for culverts at a reasonable price. A 30'x24" culvert could be purchased for \$25/foot for a total of \$750. This culvert could be cut in three 10' sections and welded to the existing three culverts at the 600 yard rifle range access road. This would allow substantial widening and stabilizing of the road.
- Jim Paxon made a motion to purchase one 30'x24" culvert for \$750. Seconded by Jim Anton. Motion passed with a unanimous vote.
