

March 6, 2024 Brady Township Meeting Minutes

Meeting called to order by Supervisor, Steve Kienitz

Attendance: Supervisor Steve Kienitz; Treasurer, Patricia Goodrich; Trustee Glen Reeves; Trustee Aaron Somers + 12. Clerk, Beverly Wenzlick absent

Motion by Aaron, supported by Glen to approve agenda Motion passed 4-0

Motion by Patty, supported by Glen to approve Clerk' minutes - last months meeting Motion passed 4-0

Motion by Glen, supported by Aaron to approve Treasurer's Report— last month report Motion passed 4-0

Before the reports we listened to Saginaw County Road Commission Dan Armentrout about the upcoming County wide millage for roads . 2 mils for 6 years. Would generate \$1 17,000/yr for Brady Township. If not all spent within a year, it does not go away until spent. It can be used along with our matching funds from the County.

Mentioned that the overlay on Hemlock Road cost the County \$225,000 2 years ago. Estimated approximately \$250,000 today to grind, put back down & overlay (cap) a mile of road.

Reports:

- a) Cemetery- RE the vandalism at Ridge Road Cemetery reported to Saginaw County Sheriff. The family is aware of the incident and have someone in mind that may have done this. In their hands now and we will just wait & see.  
Jeremy is still waiting to hear back from the family on the Draper deed transfer in order to prepare a new deed for the Board to sign. Tabled  
Steve Tkaczyk is getting close to being done with his work at the cemetery.  
Old Gas Tractor volunteers will work down the dirt that Steve has filled in at the cemetery. Grave clean off will be the same as in previous years -April 1-15<sup>th</sup>.
- b) Fire Dept - nothing to report
- c) Hall-lock on door still needs work.
- d) Planning : New member is Bernadette Schneider. Jeff Roy- Chairman, Donny Somers- Assistant Chairman, Michelle Loos-Secretary . No major changes expected to the Master Plan per Glen (it will be discussed at the April meeting the possibility of making a ruling that if we don't get a monthly report from the secretary there will be no paycheck that month.)

- e) Roads — No plan put together as yet per Steve. The Road Commission would like to have plan submitted by mid April.
- f) Board of Review- Board of Review will be March 13 from 9 to 3 and March 14 from 3 to 9.
- g) MMWA- Aaron reported that everything is going good. The transition to carts is pretty much complete. A lot of folks have purchased additional carts. We are still allowed 2 bulk items per week.

Old business - None

New Business - Steve will talk to Jim Gray about the resignation of Dan Kuhn as our Zoning Enforcement Officer.

Public Comment- Darrell Soukup brough in blank petitions for anyone that would like to circulate them to collect signatures to bring zoning authority back to local governments. If enough signatures are secured, this can be placed on the November ballot.
