Introduction

These terms and conditions establish the framework under which Tape UK conducts its business operations. Any services provided by Tape UK will be governed by the terms and conditions outlined in this contract.

Applicable Law

This Agreement and the scope of services shall be governed by and interpreted in accordance with English law. The parties agree that the courts of England and Wales shall have exclusive jurisdiction over any claim, dispute, or disagreement regarding this contract. Each party waives any right to object to legal action being brought in these Courts or to claim that the action has been initiated in an inappropriate forum.

Bribery Act 2010

Tape UK is dedicated to adhering to the requirements of the Bribery Act 2010 and has implemented policies and procedures to prevent any offering or receiving of bribes by the business and its staff.

Client Identification and Verification

To comply with UK anti-money laundering legislation, Tape UK is obligated to identify and verify clients. Work will commence upon the fulfillment of this requirement, except in exceptional circumstances. Tape UK may request and retain information and documentation necessary for client identification and verification purposes and may conduct searches of appropriate databases, including ID verification.

Commissions or Other Benefits

Tape UK may receive commissions or other benefits under certain circumstances, which will be disclosed to the client in writing.

Confidentiality

All communications between Tape UK and the client are confidential, subject to legal, regulatory, or other obligations to disclose information. Tape UK will inform the client of any conflicts of interest and will manage such conflicts appropriately.

Contracts (Rights of Third Parties) Act 1999

Only parties explicitly mentioned in this Agreement have the right to enforce its terms under the Contracts (Rights of Third Parties) Act 1999.

Data Protection

Tape UK will comply with the General Data Protection Regulation (GDPR) when processing personal data about the client and its representatives. Data processing will be necessary for contract performance, legal compliance, marketing communications, and other legitimate interests. Additional details on data processing are outlined in Tape UK's privacy notice, which should be read alongside these terms and conditions.

Disengagement

Upon resignation or at the client's request, Tape UK will issue a disengagement letter outlining respective responsibilities. In the event of no contact for one year, Tape UK may issue a disengagement letter and cease to act. Unclaimed client documents may be destroyed after six months following termination, unless other legal requirements apply.

Electronic & Other Communication

Tape UK will communicate with the client electronically, with the recipient responsible for virus-checking emails and attachments. Electronic communication risks include non-receipt, delayed receipt, and interception by third parties. Tape UK will access HMRC information as necessary and use only required data. The client is responsible for maintaining accurate contact details.

Payment Terms

Invoices issued by Tape UK are payable upon presentation. Prompt payment within 7 days of presentation is appreciated. Interest at a rate of 8% will be charged on all overdue debts after the first 14 days, as stated on the invoice. Invoices must be paid in full unless otherwise agreed by a director of Tape UK. If an invoice remains outstanding beyond the 30-day timescale, Tape UK reserves the right to engage a Debt Recovery Service to recover the funds. The client will be liable for any fees incurred by the Debt Recovery Service.

Fixed Fee Arrangements

For recurring services fixed for 24 months, Tape UK offers a 7-day cooling-off period. New and existing clients entering into a two-year fixed fee arrangement are bound by a twelve-month contract. If the client cancels the contract at any time during the first twelve months, they will be liable to pay the remaining twelve-month contract amount in full.

Fees

Tape UK's fees are available on its website, with estimates provided for specific work. Fixed fee services have a 7-day cooling-off period, with cancellation subject to contractual terms. Agreed fees are binding upon signing and payable according to invoice terms. Fixed fee quotations are valid for 7 days and may be revised due to unforeseen circumstances. Clients may be entitled to professional fee assistance, with payment ultimately remaining the client's responsibility. Tape UK may vary fee arrangements and support services at its discretion. Additional work outside agreed arrangements will incur additional fees based on time spent and skill levels. Invoices are payable upon presentation, with interest charged on overdue debts. Tape UK may suspend services or terminate engagement for delayed payments. Disputed fees must be notified within one day of receipt. A fee may be charged for handover information upon termination.

Internal Disputes

Tape UK will not take sides in disputes between parties involved in the business without the express knowledge and permission of all parties.

Investment Services

Tape UK may refer clients to authorised financial services providers for investment advice.

Insolvency Advice




