TRASH AND RECYCLING REMINDERS

There is an on-going issue with residents placing trash and recycling out at wrong times and/or after collection has occurred. Items are being dumped on common ground; as well as items the Association does not provide regular collection service for are an issue. Please take a minute to review the updated trash policy and recycling reminder, in conjunction with Montgomery County Department of Environmental Protection (EPA)

- Trash pickup is on Mondays and Thursdays.
- Recycling pick-up is on Mondays. If a Federal holiday falls on a Monday, recycling pick up will slide to the next day. Please contact the county to address concerns or issues at 240-777-0311 or www.mc311.com
- Trash should be placed out for collection after dusk the night before pick up days or alternatively the morning of pickup before 7 a.m.
- Residents of Montgomery County are required to place bags of trash inside trash cans with tight fitting lids for storage and collection.
- Recycling should be placed out in recycling bins and/or recycling cans, not in plastic bags or dumped in the grass or curbs on common ground. If you need a new recycling bin or can, please contact the county at 240-777-0311 to have one delivered to you at no cost.

- Trash cans and recycling bins must be removed and stored out of public view by the evening of pickup days and not left in public view on drive-ways, in streets, or on green spaces, such as peninsulas or islands.
- Yard and trim items should be bundled with twine for collection. Please contact the county for any concerns or issues at 240-777-0311 or www.mc311.com
- For large household appliances and other metal items, please call 240-777-0311 or visit www.mc311.com to schedule a scrap metal pick up. This service is provided to residents' yearlong; however, you need to schedule for pick up.
- <u>I & J Trash will not pick up metal</u> items.
- Bulk items are collected on Thursdays, please contact J & J Inc. 800 465-2350 for bulk pick items
- Dumping along Waters Landing Drive is prohibited and carries a \$500 fine!

2021 Holidays

- Monday, October 11, Indigenous People's Day: No change, trash & recycling will be collected.
- Thursday, November 11, Veterans
 Day: No change, trash will be collected.
- Thanksgiving Day: Thursday, November 25: NO trash collection and NO next day pick up. Please plan accordingly.
- Christmas Week & New Year's Week: No changes, trash will be collected.

Dumping of trash and bulk items is a health hazard, may cause rodent issues and is unsightly to your community. The Association is incurring additional expenses on services to clean up and remove trash items on top of the normal twice a week

trash service and once a week grounds clean up. This can affect your assessment.

Please follow these procedures to keep our community clean!

BUILDER'S CORNER

- Wet grass: If you notice grass on common ground has not been mowed it is probably due to wet grass. The area will be mowed once the area is no longer wet, but we encourage you to contact the office if you have questions.
- An AERC application is required for all changes to the exterior of your property. It is recommended to contact the Association office for specific questions.
- AERC application may be found on the Association website. <u>Click Here</u>
- Private Property High grass: Grass and weeds on private property may not exceed 12 inches in height. The Department of Housing and Community Affairs (DHCA) enforces this code on privately owned property. If the property is occupied, a case will be opened and the owner will be sent a letter advising them to cut tall grass and weeds. Please call back if grass has not been cut within 10 days of the initial complaint. If 10 days has passed and the grass has not been cut, Montgomery County will then send an inspector out to the property. You will be provided a service request number when you report the property and can check the status online or by calling: 240 777-0311, <u>www.mc311.com</u>

Permitting Requirements

 Permitting requirements from Montgomery County Permitting states the following: HOA approval is

- required to obtain a building permit. DPS suggests to always check with the Homeowners Association (HOA) before beginning a construction project. Their approval may be needed to build. Churchill/Waters Landing Town Sector in Germantown, HOA approval is required when applying for a building permit. The HOA's written approval must be presented when applying for the permit. If there is a neighborhood HOA, it is suggested that their approval be obtained and brought to DPS when applying for the County Building permit.
- Shed Requirements from DPS: All sheds require a building permit. In order to apply for a shed permit for buildings less than 200 square feet, a residential application must be completed and two copies of the site plan indicating the size of the shed, dimensions, and the setbacks to the property lines. If a shed is over 200 square feet, also provide two copies of construction drawings with footing and framing details to the 2015 International Residential Code (IRC).



FALL INSPECTION TIME

Each year homes in Waters Landing are inspected to ensure that all changes/additions to your home have been approved by the Architectural Environmental Review Committee (AERC). Changes or additions to your home can include the addition of a storm door, deck, fences, shed

or changes to exterior color, just to name a few.

In addition to ensuring that all changes/additions are approved for your home, we will also be looking for potential maintenance issues.

Single-family & townhome owners are responsible for all maintenance for their property, including but not limited to:

- a. Yard maintenance
 - i. Weeding
 - ii. Mowing
 - iii. Keep plantings trimmed
- b. Tree maintenance
 - i. Trimming of limbs
 - ii. Removal of dead trees
- c. Keep yard free of clutter and debris
- d. Painting of cracked and peeling paint on wood trim
- e. Replacement of any rotted wood
- f. Fences
- g. Roofs
- h. Siding
- i. Shutters
- j. Gutters/Drain Spouts
- k. Decks
- l. Patios
- m. Porches
- n. Washing of siding to remove mold build-up
- o. Sidewalks that lead to your home
- p. Driveways

If you have been notified of a violation during the spring inspection or receive a violation for the fall inspection, please contact the office via email wla@waterslanding.org or call 301 972-3681. You can request an extension or notify us for an re-inspection of the violation.



TREES

If a neighboring or common ground tree falls into your property, you are responsible for the tree. The Association will attempt to remove a common ground tree from your property. For damages to your property, you should contact your Homeowners Insurance. If tree branches from a neighboring tree or common ground tree is encroaching on your property, you are allowed to trim back to your property line.

Tree maintenance requests on common ground trees should be reported to the Association office. The timeframe once reported is 6 to 10 weeks.

ENCROACHING ON COMMON GROUND

Encroachment, which is surpassing property boundary lines onto Association common ground without permission, is prohibited. Items on common ground are subject to removal by the Association at the owner's expense.



STREETLIGHT OUTAGES

Streetlights are inspected about once a month for outages. If you notice there is a streetlight that is either out, dim, flickering, or on during the day, you may contact Potomac Edison (PE) directly as PE owns and maintains all streetlights. For your convenience, we have prepared a streetlight map listing all streetlights with

NEIGHBORHOOD ADVISORY COUNCIL (NAC)

The Association recently sent out a (orange) mailer to Waters Landing residents in the single-family & townhome communities regarding re-establishing a NAC in your neighborhood. We have received interest and we are excited! As noted in the mailer, the NAC is activated to address issues in your specific neighborhood and function as a liaison partner to the Board of Directors. The Neighborhood Governance of the NAC is located in Article VII of the By-laws. Please contact the Association office with questions or if you are interested in participating.

HOMEOWNER ASSOCIATION (HOA) VS CONDOMINIUM ASSOCIATION (CA)

What's the difference?

Home Owners Associations manage fee simple properties (private property) and common ground. HOAs have fee simple properties (private property) within the community and the HOA is responsible for maintaining, repairing, and replacing common areas, which can include sidewalks, parking lots, path system, green spaces, trees, pools, tennis courts, multi-use courts, and tot lot playgrounds.

Condominium Associations are responsible for all the general common and limited common elements, such as lobbies, common hallways, sidewalks, roofs, and parking lots.

Did you know there are *six* Condominiums within Waters Landing? Do you live in a

Condominium? If you live on Deerwater Drive, Ambassador Drive, Ambassador Terrace, Pickering Court, Beaconfield Terrace, Shipley Terrace, Shore Harbour Drive, Shadyside Lane, Shadyside Way, you live in a condominium. Please contact your condominium management company with questions for your day-to-day operations & for condominium Board meeting information.

Waters Landing Homeowners Association does not handle your day-to-day operations. We handle recreational amenities only, which are pools, path system, tennis courts, multi-use court and basketball court amenities.

SHOPPING CARTS IN WATERS LANDING

We have noticed on recent inspections shopping carts randomly moving through out Waters Landing. We have contacted the various grocery stores to which the carts belong to and have been told this is a big issue for the stores. The Association has to incur an expense to remove these items from Waters Landing property when the stores are not able to dispatch in a timely manner. Please do not remove shopping carts from any stores, this is considered illegal use. This is crucial for preserving our community and the environment. According to the Food Marketing Institute "approximately 2 million shopping carts get stolen from businesses costing the average store about \$8,000-\$10,000 annually."

Within the last 90 days, 71 (total) homes have sold in Waters Landing. Here's the breakdown (separating by single family, townhomes and condos:)

Single Family Homes Sold

- 15 homes sold

Townhomes Sold

- 34 homes sold
- price range was \$220,00 \$453,000
- average closed price \$344,500
- average days on market was 12

Condominiums Sold

- 22 homes sold
- price range was \$165,100 \$335,000
- average closed price \$242,727
- average days on market was 13

The average days on market for all home types was 13. The average closed price for all home types sold within the community was \$344,500. The average closed price as a percentage of list prices was 102.09% (ie. on average homes sold .02% over list price.)

If you are selling your home, you are required by law to provide the prospective buyer with a set of Homeowner Association documents. Don't risk the legal problems that can come from a lack of full disclosure on your resale. The Waters Landing resale package is available for purchase by order through the Association office. We ask that you place your request a minimum of 5 days in advance, allowing sufficient time for preparation.

Neighborhood: Gables/Manorwoods

Gables/Manorwoods is a single-family neighborhood located across Waters Landing Elementary School. Within the

neighborhood, there are two styles of feesimple single-family units: zero-lot line and duplexes. Homes back up to Waters Landing Dr., Father Hurley Blvd. & Crystal Rock Dr.

The Gables/Manorwoods neighborhood is located on county owned streets. Concrete work, asphalt, storm drains, snow removal

and vehicle issues are under the jurisdiction of Montgomery County.

Properties in GBLS/MAN: Alderleaf Court (16); Alderleaf Drive (28); Alderleaf Terrace (36); Bargene Court (18) and Bargene Way (34) Total: 132

The Gables area have zero-lot line homes, which are located on Alderleaf Terrace, Bargene Court and Bargene Way.

The Manorwoods area are duplex homes located on Alderleaf Court and Alderleaf Drive.

Zero lot lines: Detached homes where the property line runs up to the structure.

<u>Duplexes:</u> Two attached single-family units.

Home Style: Victorian and Colonial

Neighborhood Notes: A NAC was established for a 2012-2013 fence vote and was approved by the neighborhood for 6 foot fences. The NAC dissolved afterwards, since it was established for this issue only.

There is a memorial area on Bargene Court in memory of a Gables/Manorwoods resident.
