1 on 1 Instruction - Student Contract

Safe Road Driving Academy, LLC agrees to provide the following:

- 1 on 1 Private Instruction with a certified and highly qualified instructor. Training will begin with an evaluation of the students driving skills and knowledge, followed by instruction and practice as required. All training is geared to the students needs and will prepare the student for Behind the Wheel and eventual licensing when eligible.
- Each training session is 60 mins. and can be scheduled separately or in packages of 3, 5, or 10. Other packages are available upon request and may be suggested by the instructor.
- Pick up and drop off is included in each training session.
- Student agrees to pay the required fee in full prior to training. (Cash, Check, Credit/Debit Card, PayPal)
- Payment is due no later than the first day of training.
- Checks - made payable to Safe Road Driving Academy, LLC

The School and the Student/Parent/Guardian agree to the following terms and conditions:

- Full payment is due at or prior to the first session
- There is a **\$35.00** fee for returned checks.
- Training is conducted by appointment only and the Student will be charged a **\$25.00** service charge for any appointment he/she does not meet, unless the school is given at least 24 hours of notice.
- No Certificate for Completion will be issued until all fees have been PAID IN FULL.
- The School will not refund any monies or any part thereof when actual services have been rendered.
- The School will complete the course in a reasonable length of time. However, it cannot be held responsible for delays caused by mechanical failure, unsafe driving conditions due to weather, or any other reason over which it has no control.
- The School will give the Student as much notice as possible if any delay becomes necessary (or foreseen).
- The School will notify the Student in the event the School cancels classes. Cancelled classes will be made up at the end of the course.
- Student is fully accountable for their conduct. They can be dismissed from the course for misbehavior without refund.
- No food, drink, smoking, or sleeping and cell phones must be turned off.
- A **\$25.00** fee will be charged for replacement of lost certificates.
- The School agrees to exert its best efforts in teaching the Student to meet the requirements of the examinations. However, there is no guarantee the student will pass the DMV road test, secure a drivers license or be granted employment at the conclusion for this course.
- The fees set out herein are guaranteed for ninety (90) days from the date of this contract.
- The Student understands that certain hazards and risks are inherent in the operation of motor vehicles.
- The Student does hereby specifically assume all risks as may be incurred in the normal operation of a motor vehicle during the course instruction. All vehicles are fully covered with Liability Insurance.

Parent or Guardian:

It is mandatory that you provide your child with a minimum of FORTY-FIVE (45) hours of additional supervised Behind the Wheel driving conducted prior to license issuance. *Additionally, A parent or guardian must participate with the student in an additional 90-minute driver education component as part of the in-classroom portion of the driver education curriculum. The parent or guardian and student will be required to sign an Affirmation of Attendance, DMV form DTS 90, to acknowledge completion of the required 90-minute component.*
