- 1. Legislative Work
 - a. Organic Dairy Assistance, Investment, and Reporting Yields Act of 2023 (O DAIRY Act of 2023)
 - b. "The organic Dairy Data Collection Act"
 - i. Improved data collection for organic dairy
 - ii. Introduced by Congresswoman Pingree and Congressman Molinaro

- Fly In advocacy scheduled for early February focusing on the Organic Market Development Act and CIAO
- 2. ODMAP
 - 1. OTA is engaging with USDA. They have indicated they want to continue the program but there are other priorities they are focusing on (appropriations, farm bill). Awaiting follow up from USDA.
- 3. Organic Market Development Grant
 - 1. Still waiting on USDA to announce the successful applicants.
- 4. NOSB
 - 1. 5 seats opening in January 2025 on NOSB. They want to get those filled by October 2024. Currently no dairy representatives on the Board.
 - 2. Spring 2024 meeting is April 29th diving into the next round of sunset materials.
