2. Milk Pooling

- 2. Organic has tried to get out of it a few years ago, effort fell flat. If organic got out of the pool, we could form an organic pool or not. Conventional benefits from organic being in the pool, organic always pays in.
 - i. There are some benefits:
 - 1. FMMO collects the information so there is some data
 - 2. If you're outside of the pool it will be hard to get in line for a new processor.
 - a. Pool plants gave message that if you're out of the pool you're out and you wont have access to emergency processing etc. on fluid market this is a big deal.
 - 3. How will being out of the pool improve the pay price for producers?
 - 4. There is no way to stay in the pool but not always pay in.
- 3. Dan Smith New England Compact, VT Task Force, FMMO, Former staff attorney for VT legislator, Maine Dairy Industry rep.
 - 1. Recap of conversations he's had on the Hill with reference to DMC and the possibility of an organic margin insurance program. He was on the Hill 3 weeks ago.
 - i. Main Question: Is Congress open to any organic dairy programs and how can we create it?
 - 1. Does it make sense to work together going forward? What would that look like?
 - 2. Is WODPA interested in supporting?
 - a. Hesitancy given that \$\$ would have to come out of existing pots.

- b. Working to have organic dairy as a premium specialty product rather than a commodity. How would this impact that push?
- c. Look at an established program like CCC or ELAP.

- NOP is seeking public comment on the burdens, costs, and other effects of the information
 collection required by the final rule, which adds a process by which organic operations may
 request a variance, or exception, from certain livestock sourcing requirements. Online comments

 by clicking the link below. The 60-day comment period will close on June 26, 2023.

 - a. Introduced by Senator Welch
 - b. The bill is cosponsored by Senators Tammy Baldwin (D-WI), Cory Booker (D-NJ), Bob Casey (D-PA), John Fetterman (D-PA), Kirsten Gillibrand (D-NY), Angus King (I-ME), Ed Markey (D-MA) Chris Murphy (D-CT), Alex Padilla (D-CA), Bernie Sanders (I-VT), Tina Smith (D-MN), and Ben Ray Lujan (D-NM).
 - c. Being introduced in the House very soon!
 - d. Reimburse up to \$1500 in organic certification costs
 - e. Provide flexible transition and resilience funding (from training and purchasing equipment to business planning and market development)
 - f. Ensures public institutions and NGOs provide regionally appropriate and organic relevant technical assistance to help farmers reduce reliance on costly inputs and build healthy soil to stabilize farm incomes and our food supply
