- 2. OFA's National Organic Dairy Call 2/27/2023
 - a. Farm Bill Priorities:
 - Immediate support to address dramatically increased input costs for organic dairy farms
 - ii. Investment in organic milk processing infrastructure that serves major US organic dairy producing regions.
 - iii. Improved data collection for organic dairy
 - iv. Propose a safety net program for organic dairy farms, based on organic –
 specific milk and input cost data (create and enact a safety net program within 1 year of bill passage)

 - a. Work Plan items for 2023 include:
 - i. SOE Implementation support
 - ii. Improve Organic Crop insurance offerings.
 - iii. Market development:
 - 1. Protect existing organic producers who are experiencing a price halt.

 - 4. Legal changes to allow more direct marketing to consumers.

 - v. Keep organic standards high.
 - vi. Address core issues causing organic dairy challenges.

 - viii. Encourage organic seed usage.
