 - c. Continuing resolution passed on September 30th to keep the government open until November 17th.

- 9. NOSB Topics:
- a. Inerts used in organic pesticides.
- Coming out as a discussion document
 - b. Annotations
- When it comes to a sunset review, no changes or annotations could be made on a material. The Board is now proposing that annotations be allowed to suggest in the Spring, vote in the Fall. The sunset of materials will be voted on separately from the annotations proposed.
 - c. Compost
- Petition before the Board for compostable synthetics (i.e. forks, spoons, etc.)
 - d. Residue testing
- Farms can be tested at any time. Standards are not given for handling. How can this be changed?
 - e. Geolocation to prevent fraud.
- Proposal passed but proposal was expanded.
 - f. Crop insurance
- Not part of the NOSB purview but the Board thought putting a discussion item out could inform the Risk Service Agency. They did indicate some changes are being made due to these comments.
