Tuesday, June 9th, 2020 7:00 pm (EST)

Call to Order

Chairwoman Deli Houseal (7E06) called the meeting to order at 7:04 pm. The following commissioners: Veda Rasheed (7E01), Linda S. Green (7E02), T.N. Tate (7E04), and Victor Horton (7E05) were present. Commissioner Yolanda Fields (7E07) was delayed, but did attend the meeting.

Commissioner Ebbon Allen (7E03) was absent.

Approval of the ANC's June's Meeting Agenda

Chairwoman Houseal moved to have June's public meeting agenda approved. It was motioned and passed.

Approval of the ANC's May's Public Meeting Minutes

Chairwoman Houseal moved to approve the ANC's May's public meeting minutes. The motion was voted on and passed.

Monthly Treasure

The treasure's report was given by the Executive Assistant as Commissioner Fields had not arrived on the call at that time.

Commissioner Horton noticed that a line item for public safety was omitted. Commissioner Houseal suggested that Budget be amended to display a line item for Public Safety in the amount of \$10,000. From the Public Safety Budget, \$5000.00 will be allocated to purchase PPEs. Commissioner Tate motioned to approve the Amended budget, Commissioner Horton seconded the motion, and the motion was passed.

Several questions from the commission were complied around the areas of mental health, violence interruption and unemployment benefits. Highlights of the responses are: The budget will provide funding for violence prevention programs in schools. There are funds allocated for early childhood education. Park and Recreation centers will receive funds for remodeling. Information for unemployment benefits, tenant and homeowner assistance, along with assistance for utility bills were provided.

- Unemployment benefits: It generally takes 21 days from the time all necessary documentation from a claimant is received. For more information, there is a hotline phone number: 202-724-7000, as well as email address: COVID19.ui@dc.gov
- For Tenants and Homeowner assistance: The Office of the Tenant Advocate (202) 719-6560 for assistance with your landlord and Department of Insurance, Securities and Banking (202) 727-8000 for assistance with banks and any foreclosure issues. In addition, the Office of the Attorney General has a consumer protection hotline at (202) 442-9828 that can also be reached.
- Residents who need assistance with utility bills can reach out to The Department of the Energy and Environment through 311 to set up an appointment for assistance. There are federal and local funds available so please reach out.

Mental health support for ward 7- The budget will provide funds to expand school based mental health programs. Two million dollars from the Federal government was given to the Department of Behavioral Health, to provide grants to providers for counseling.
