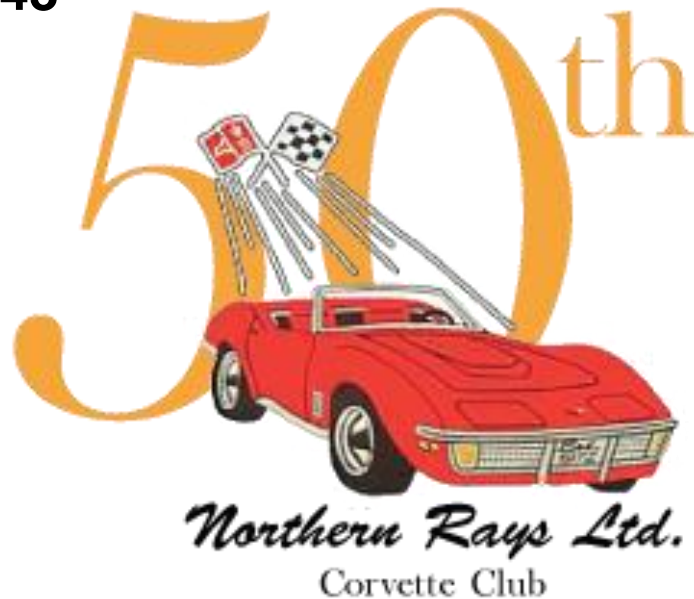

The next 3 pages regard a proposed bylaw change for the Northern Rays Corvette Club. This is in regard to Membership and the different classes of Membership and to bring us in line with the Membership types offered by NCCC.

The items highlighted in red are the verbiage that the club wants to change.

The items in green are the proposed verbiage changes.

Our Bylaws stipulate three things must happen to Amend our Bylaws:

1st meeting: Parliamentarian reads proposed changes (already read in the January club meeting)

The proposed Amendment is published in Reporter

2nd meeting: Discussion by membership of proposed changes

3rd meeting: No more discussion allowed, vote on Amendment takes place

$\frac{3}{4}$  majority of all voting members present or represented by absentee ballot is needed to pass Amendment

### Section 1. Membership

- A. To be eligible for membership to N.R.L. the prospective member or their spouse must own and be able to prove ownership **of a Corvette** at the request of officers. (amended 2/23/2002)
- B. Prospective members must attend (2) meetings and/or events and work at one (1) Club event or function within a twelve (12) month period to qualify for membership. (amended April 2012)
- C. Prospective members must be 18 years of age or older, except in the case of associate members (see "F" below).
- D. If both husband and wife join N.R.L. they will both also join N.C.C.C. the first year. After the first year of N.C.C.C. membership it is only mandatory for the primary club participant to rejoin N.C.C.C. (amended 2/23/2002)
- E. Deleted May 8, 1990
- F. Prospective Associate Members must be children of Active N.R.L. members and:
  - 1. must be a minimum of 16 years of age, but less than 18 years of age.
  - 2. must attend their (3) meetings and/or events within a twelve (12) month period to qualify for Associate membership.

### Section 2. Classes of Membership

- A. Active-Any person duly approved as provided in Section 1 of this Article and having paid such annual dues and fees as required and having attended at least three (3) N.R.L. meetings, events and/or functions within the year. An Active member must be over 18 years of age.
  - 1. Spouse – The spouse of any Active member may become a member upon the payment of required membership dues and fees. Such members shall be entitled to all privileges of active membership.
  - 2. Active members and Active members spouse are required to dedicate all National and Regional Championship Points earned to Northern Rays Limited Corvette Club. Failure to do so will result in the loss of all privileges afforded an active member.
- B. Associate – any child of an active N.R.L. member 16 or 17 years of age.
- C. Military Leave – Any existing member who is away in temporary military service shall not be required to pay dues for the duration and shall still have all the privileges of an Active member.
- D. Honorary – Any person who has commended them self to Club esteem and who may be elected at a business meeting by a ¾ majority vote of the members present, with no time limit on the membership. (amended 2/23/2002)
  - 1. Any person nominated for Honorary membership must be **reviewed** by the Board of Officers prior to a vote. The election for Honorary membership shall take place at the business meeting following nomination.

### Section 1. Membership

- A. To be eligible for membership to N.R.L. the prospective member or their spouse/companion must own and be able to prove ownership **of a Corvette** at the request of officers **except as otherwise provided in these Bylaws**. (amended 2/23/2002)

- C. Prospective members must be 18 years of age or older, except **as otherwise provided in these Bylaws**.
- D. **All members of N.R.L. must also belong to N.C.C.C.**

G. **Members must pay annual dues and fees as required.**

**Section 2. Classes of Membership**

A. **Primary**-Any person duly approved as provided in Section 1 of this Article.

1. **Spouse/Companion** – The spouse **or companion** of any **Primary** member **and whose mailing address is the same as the Primary.**

2. **A Primary or Spouse/Companion member who have chosen to dedicate their National and Regional Points to another N.C.C.C. club will lose all privileges afforded an active member.**

B. **Youth** – any child of **a Primary member who is between the ages of 16 and 21, or between the ages of 16 and 25 and also a full time student, and whose mailing address will be the same as the Primary member.**

C. **Military Leave** – Any existing member who is away in temporary military service shall not be required to pay dues for the duration and shall still have all the privileges of an **active member.**

D. **Honorary** – Any person who has commended **himself** to Club esteem and who may be elected at a business meeting by a  $\frac{3}{4}$  majority vote of the members present, with no time limit on the membership. (amended 2/23/2002)

1. Any person nominated for Honorary membership must be **approved** by the Board of Officers prior to a vote **by the members.** The election for Honorary membership shall take place at the business meeting following nomination.

2. **Honorary members shall be exempt from payment of dues and shall be entitled to all the privileges of active membership except the right to vote or hold office. Honorary members need not own a Corvette.**

E. **Associate** – A former N.R.L. member who no longer owns a Corvette.

1. An Associate member shall be entitled to all the privileges of active membership except the right to vote, hold office or compete for National or Regional points.

F. **Enthusiast** – Any person who is a Corvette enthusiast and meets the membership requirements in Section 1 of this Article except that they do not own a Corvette.

1. An Enthusiast member shall be entitled to all the privileges of active membership except the right to vote, hold office or compete for National or Regional points.

3. Please **state in detail**, why you think this Bylaw should be changed:

These updates bring our NRL membership rules into line with how we currently run the club and broadens our Membership classes to include all types of Membership offered by NCCC.

These changes bring us into line with the actual practice we follow when bringing on new members. Broadening the types of Membership Classes will also allow us to bring in other new members that may not have qualified for membership in NRL previously but did qualify for NCCC membership.

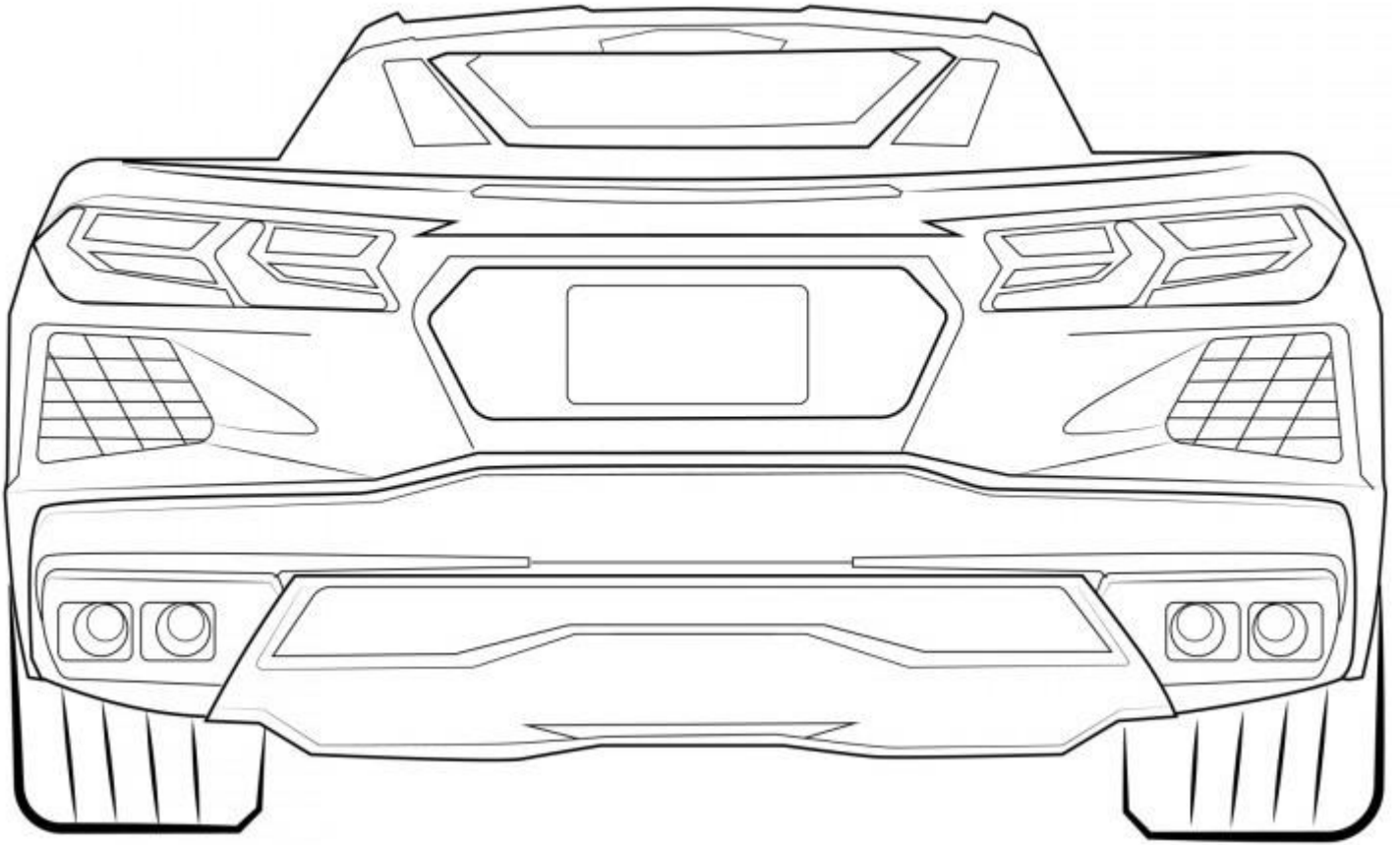
