

BYLAWS

(A NOT-FOR-PROFIT CORPORATION)

Modified 7-2023 Computerized 1-1-96

VERIFIED BY BOARD mm/yyyy

ARTICLE I

Section 1. Name

The name of the club shall be the **NORTHERN RAYS LIMITED**, (N.R.L. or the Club). Northern Rays Ltd. is a Not-For-Profit Corporation, incorporated in the State of Illinois.

Section 2. Purpose

The purpose or purposes for which the corporation is organized are:

- A. To promote the sport and pastime of motoring in all its aspects and, in particular, to further the interests of owners and drivers of Corvette cars and of those persons interested in Corvette cars and the general purposes of this organization.
- B. To act as a source of technical information.
- C. To promote and sponsor, organize and supervise motorcar outings, meetings and competitions, (i.e. rallies, concourses, speed events) and other events, whether motoring or otherwise. To offer prizes and awards in respect thereof or make such arrangements and commitments as may be necessary for any such purpose.
- D. To buy, sell, lease, own, mortgage, encumber and otherwise deal in property, real, personal, and mixed, for purposes incidental to the foregoing purposes; and to do all things necessary or appropriate in the furtherance of the foregoing purposes.
- E. To promote and sponsor, organize and supervise social and charitable activities.

Section 3. Location

The club shall maintain in the State of Illinois a registered office and a registered agent (any may have other offices within or out of the State).

Section 4. <u>Directors</u>

The Board of Directors shall be comprised of the Board of Officers.

ARTICLE II

Section 1. Membership

- A. To be eligible for membership to N.R.L. the prospective member or their spouse/companion must own and be able to prove ownership of a Corvette at the request of the officers. (amended 2/23/2002, 3/14/2023)
- B. Deleted 3/14/2023
- C. Prospective members must be 18 years of age or older, except as otherwise provided in these Bylaws. (amended 3/14/2023)
- D. All members of N.R.L. must also belong to N.C.C.C. (amended 2/23/2002, 3/14/2023)

- E. Deleted May 8, 1990
- F. Deleted 3/14/2023
 - 1. Deleted 3/14/2023
 - 2. Deleted 3/14/2023
- G. Members must pay annual dues and fees as required. (added 3/14/2023)

Section 2. Classes of Membership

- A. Primary Any person duly approved as provided in Section 1 of this Article. (amended 3/14/2023)
 - 1. <u>Spouse/Companion</u> The spouse or companion of any Primary member and whose mailing address is the same as the Primary. (amended 3/14/2023)
 - 2. A Primary or Spouse/Companion member who have chosen to dedicate their National and Regional Points to another N.C.C.C. club will lose all privileges afforded an active member. (amended 3/14/2023)
- B. <u>Youth</u> any child of a Primary member who is between the ages of 16 and 21, or between the ages of 16 and 25 and also a full time student, and whose mailing address will be the same as the Primary member. (amended 3/14/2023)
- C. <u>Military Leave</u> Any existing member who is away in temporary military service shall not be required to pay dues for the duration and shall still have all the privileges of an active member. (amended 3/14/2023)
- D. <u>Honorary</u> Any person who has commended themself to Club esteem and who may be elected at a business meeting by a 3/4 majority vote of the members present, with no time limit on the membership. (amended 2/23/2002, 3/14/2023)
 - 1. Any person nominated for Honorary membership must be approved by the Board of Officers prior to a vote by the members. The election for Honorary membership shall take place at the business meeting following nomination. (amended 3/14/2023)
 - 2. Honorary members shall be exempt from payment of dues and shall be entitled to all the privileges of active membership except the right to vote or hold office. Honorary members need not own a Corvette. (amended 3/14/2023)
- E. Associate A former N.R.L. member who no longer owns a Corvette. (added 3/14/2023)
 - 1. An Associate member shall be entitled to all the privileges of active membership except the right to vote, hold elected office or compete for National or Regional points. (added 3/14/2023)
- F. <u>Enthusiast</u> Any person who is a Corvette enthusiast and meets the membership requirements in Section 1 of this Article except that they do not own a Corvette. (added 3/14/2023)
 - 1. An Enthusiast member shall be entitled to all the privileges of active membership except the right to vote, hold elected office or compete for National or Regional points. (added 3/14/2023)

Section 3. <u>Dues and Fees</u>

- A. The amount of annual dues and initiation fees shall be determined by the general membership. Any change in dues or fees shall be accomplished in the manner as prescribed for a bylaw change.
- B. Annual dues and fees shall be outlined from time to time in the Club newsletter. (amended 5/9/2023)
- C. Deleted 5/9/2023
- D. Payment of Dues and Fees dues and fees become payable upon the date of the September business meeting. Membership runs from Jan 1 to Dec 31 yearly. (clarification 2/23/2002. (amended Dec. 8, 2003)
 - 1. <u>Default</u> When any member shall be delinquent in payment of dues or fees for a period in excess of two (2) months from the due date, his membership may be terminated.
- E. Dues and fees paid by members are nonrefundable.
- F. There shall be no dues or fees for Honorary members or those classified as Military Leave members.
- G. Deleted 5/9/2023

Section 4. Privileges

Any person who has met the Membership requirements in Section 1 of this Article is an active member. Except as otherwise provided in these Bylaws, active members are entitled to all Club privileges. (amended 5/9/2023)

Section 5. Transfer of Membership

Membership in this Club is not transferable or assignable.

Section 6. Expulsion

- A. Any member may be expelled for any of the following reasons:
 - 1. Violation of Club bylaws in effect at the time of action.
 - 2. Unsportsmanlike conduct of an extreme nature.
 - 3. For compromising the safety of either, himself, his fellow Club members or other individuals.
 - 4. Default of dues and fees (see Article II, Section 3, D). (amended 5/9/2023)
 - 5. Damage to or destruction of the property of the Club, its members or other individuals.
 - 6. Conduct detrimental to the image of the Club.
- B. Procedures for Expulsion:
 - 1. A signed written complaint must be presented in person to the Board of Officers.
 - 2. Any officer at issue must remove himself from expulsion proceedings.
 - 3. The complaint will be reviewed by the officers at a formal meeting within 30 days, and a determination whether to proceed will be made by a three-quarter (3/4) majority vote of the Board of Officers. A Quorum of officers must be present.
 - 4. If the Board of Officers determines to proceed, a formal written notice will be presented to the member in question. That member shall be given the opportunity to respond to any charge brought against them at a formal officers meeting. Any oral response must also be submitted in writing.
 - 5. A final determination will be made by a 3/4 vote of the Quorum of the Board of Officers present and a written determination will be sent to the member in question. The determination of the officers is final. The decision becomes effective immediately. Notice to the Club members will be made at the next meeting concerning the decision.
 - 6. If the member in question chooses to resign from the Club, all charges will be dropped.

ARTICLE III

Section 1. Monthly Meetings

- A. Monthly meetings shall be held on a regularly designated day and Robert's Rules of Order shall be used as a guide for standard operating procedures.
- B. The meeting day (date) may be changed for special circumstances and sufficient notice shall be given. December shall be designated as the annual meeting.

Section 2. <u>Board of Officers Meeting</u>

The Board of Officers shall meet at least once a year at a time and place proposed by the Vice President. (amended 4/11/2023)

Section 3. Special Meetings

Special meetings of the members or officers may be called by the President, by a majority of the officers or by a majority of the members. Minutes of such meetings shall become part of the permanent Club records, and be made available to any Club member upon request.

Section 4. Notice of Business Meetings

A. Notice of Monthly business meetings, stating the place, day, and time shall be published in the monthly newsletter and on the club website. (amended 4/11/2023)

B. Notice of Special meetings, stating the place, day, time, and purpose shall be emailed by the Secretary to all members who have provided an email address at least seven days prior to the date of the Special meeting. The notice should also be put on the club website. (amended 4/11/2023)

Section 5. Quorum

- A. At all stated meetings of the general membership, any amount in attendance of the active and associate members shall constitute a Quorum. (amended Dec. 8, 2003)
- B. At all stated meetings of the officers, 2/3 or more of the voting officers shall constitute a Quorum.

ARTICLE IV

Section 1. Number and Term of Officers

The Club shall have officers as described in Article V. The elected officers of the Club shall serve for one year or until their successors are elected and qualified, with exception of the Treasurer which shall be for two years. Terms of office will begin on January 1st and run for one calendar year. One member may hold more than one Board position but will only have one vote if the positions are voting Board positions. (amended July 2006 and 6/13/2023)

Section 2. Nomination and Election of Officers

- A. Election of officers shall be held at the meeting in November. All officers shall be the people who receive the highest number of votes. Members in good standing wishing to vote by absentee ballot shall request it from the Secretary and return same to the Secretary prior to the election meeting. In the event of a tie, a revote will be taken between candidates that have tied.
- B. Candidates names will appear on the ballot in the order of nomination.
- C. Candidates qualifications will be available and read aloud prior to the vote for prospective offices.
- D. Nominations for officers shall be held at the October and November business meetings.
- E. At the conclusion of nominations for all offices on the day of election, once nominations are closed, they shall not be reopened except in the case of extraordinary circumstances. Extraordinary circumstances shall be defined as a situation where a necessary office vacancy occurs and must be filled.

Section 3. Eligibility to Hold Office

To be eligible to run for or hold office:

- 1. A candidate must be in a class of Membership (see Article II, Section 2) which allows them to hold office (amended 6/13/2023).
- 2. Deleted July 2006
- 3. And not hold office concurrently with any other N.C.C.C. sanctioned club.

Exceptions to this will be as follows:

- 1. An individual holding elected or appointed office at the N.C.C.C. National or Regional Level.
- 2. Members of N.R.L. appointed by the President to an unfilled office after the six (6) month period following normal elections shall be allowed to run for the office in which they serve.

Section 4. Resignation and Appointment

In the event that any of the aforementioned officers resign, or become unable to hold office before the end of the elected term, the President shall, at his option, appoint a member or request an election to fill the vacancy of said term. If the vacancy occurs more than six (6) months prior to normal elections, the office **will be** filled by election. Officers appointed by the President shall be allowed to vote at Board of Officers meetings provided their Job Description allows.

ARTICLE V

Section 1. Duties of an Officer

In addition to performing the designated function of his office, a member of the Board of Officers is entrusted with the responsibility of establishing Club policy, upholding the bylaws of the Club, carrying out the purpose of the Club, and, above all, acting in the best interest of the Club and its individual members. It is also their duty to attend Club meetings and functions.

Section 2. <u>Duties of the President</u>

The President shall be the Chief Executive of the Club. The President shall preside at all meetings of the members and shall have the responsibility for the general control and management of all Club activities. He is responsible for the care and custody of all Club property and shall maintain an up-to-date record of all such property, which shall include the name of any member charged with temporary custody thereof. He may call special meetings under the provisions of Article III. He shall be an ex-officio member of all committees and preside at the Board of Officers meeting in the absence of the Vice President. Other responsibilities include regular communication with the other officers and committee chairmen to ensure coordination of functions and successful completion of activities. He shall appoint a parliamentarian and web master on a yearly basis or as necessary. (amended 2/23/2002 and 7/11/2023)

Section 3. <u>Duties of the Vice President</u>

In the absence of the President or in case of his death, resignation or inability to act (which will be determined by the Board of Officers), the duties usually appertaining to that office shall be performed by the Vice President. He shall serve as Chairman of any Board of Officers meeting. He shall serve as Director of social and noncompetitive activities. He shall also actively promote the name of N.R.L. in the community. (amended 7/11/2023)

Section 4. <u>Duties of the Secretary</u>

The Secretary shall attend all meetings of the members and officers and shall record all minutes and the outcome of all votes. He shall submit for publishing in the newsletter or by email to all members who have provided an email address. He shall give all notices of meetings to the members required by law or these bylaws and shall perform all duties incidental to this office required by law or the majority vote of the officers. He shall have custody of the Club's records and keep all Club correspondence. He shall be responsible for absentee voting as detailed in Article IV, Section 2 and Article IX. In the absence of the Secretary from any meeting, a Secretary pro tempore shall be chosen by the presiding Officer. The Secretary shall also act as Club Historian. (amended 7/11/2023)

Section 5. Duties of the Treasurer

The Treasurer shall, subject to such conditions and restrictions as may be made by the officers, have custody of all monies, debts, and obligations belonging to the Club. He shall receive monies for the Club and deposit it in the Club account. All CONTRACTS, CHECKS, DRAFTS, NOTES OR OTHER ORDERS FOR PAYMENT OF MONEY SHALL BE SIGNED BY THE TREASURER AND PRESIDENT OR VICE PRESIDENT. If these three positions are held by the same member, another co-signer will be selected by the Board of Officers. Also, a co-signer may not be of the same household or related by blood or marriage to the Treasurer. If this should occur, another co-signer will be selected by the Board of Officers. (amended July 2006 and 7/11/2023)

The Treasurer shall prepare a budget for approval by the Board of Officers. Any payments within 10% of the budgeted amount or not exceeding \$25 of the budgeted amount may be paid by the Treasurer. If an obligation does not meet these criteria, the payment must be approved by the Board of Officers. The Treasurer shall give a report on the financial status of the Club at the monthly meeting, and, if so requested, at any other meeting of the Officers. (amended 7/11/2023)

The Treasurer shall also be responsible for maintaining the Corporate and Not-For-Profit status of the Club.

Section 6. Duties of the N.C.C.C. Governor

The Governor shall attend the N.C.C.C. meeting(s) in accordance with N.C.C.C. rules, and shall be reimbursed by the Club for such expenses as approved by the Board of Officers. His duty shall be in compliance with the duties outlined in the N.C.C.C. Rule Book.

Section 7. <u>Duties of the Director of Competition</u>

The Director of Competition shall be responsible for the administration of all Club sanctioned and Competition events. He shall be the resident authority for any conversation relative to competition. He shall also be in charge of award acquisition for any Club oriented events.

Section 8. <u>Duties of the Membership Director</u>

The Membership Director shall be charged with the responsibility for keeping up-to-date records of all members. He shall be in charge of collecting monies due for membership, both initial and renewal. He shall be in charge of selling club property at the Club function. He shall be responsible for contacting all prospective members who have expressed an interest in Club membership. (amended 7/11/2023)

Section 9. Duties of the Publication Director

The Publication Director shall be in charge of Club newsletter. He shall be the Editor, Writer, Publisher and distributor of this publication. At his discretion he may designate any or all of these functions to volunteers. If done so, he shall be final authority and hold full responsibility for this publication, within reason. (amended 7/11/2023)

Section 10. <u>Duties of the Director of Public Relations</u>

The Director of Public Relations shall be responsible for the advertising of upcoming Club events, and also for any post event articles. He shall also be responsible for promoting the name of the Club in the community.

Section 11. Duties of the Sergeant-At-Arms

The Sergeant-At-Arms will be the policing body at any Club function, or gathering of Club members. He shall keep order at the meetings and use whatever methods are necessary to do so, including physical expulsion. He shall do his best to protect any Club property as well as the personal property of any member and guests. He shall also be charged with the responsibility of assisting the Membership director in making any guests feel welcome. (amended July 2006)

Section 12. <u>Duties of Parliamentarian</u>

The Parliamentarian shall act in an advisory capacity to the President and the Board of Officers regarding the proper conduct of any meeting. He shall be the Chairman of the Bylaws Committee. He shall be appointed by the President but must be approved by a 3/4 majority vote of the Board of Officers. This is a non-voting Board position.

Section 13. <u>Duties of the Web Master</u>

The N.R.L. web site shall be prepared and maintained by an appointed Web Master. The duties of the Web Master shall include but not be limited to preparing and maintaining the N.R.L. web presence. The Web Master will be responsible for keeping the site current at all times. The site shall contain all pertinent Club information. Any changes will require the approval of the board of officers prior to posting. The site shall be done in a true Corvette fashion and in good taste. He shall be appointed by the President but must be approved by a 3/4 majority vote of the Board of Officers. This is a nonvoting Board position. (*Added* 2/23/2002)

ARTICLE VI

Section 1. Appointment of Committees

The President shall appoint such committees as he finds desirable from time to time and shall outline the duties and responsibilities of such committees. Any officers may appoint committees within the boundaries of his office. Such committees must have the approval of the Board of Officers. All reports or actions taken by a committee must be voted by a majority of the entire committee. The Board of Officers has final approval of all committee action.

Section 2. Activities

The activities of the Club shall consist of planned trips, social gatherings, and events for Corvette owners (as outlined in Article I, Section 2) and planned by the membership, or its designated chairman.

A. At no time shall the Club provide any alcoholic beverages at any of its activities.

ARTICLE VII

Section 1. Fiscal year

The fiscal year of the Club shall be from January 1st to December 31st.

ARTICLE VIII

Section 1. Personal Liability

All persons or corporations extending credit to, contracting with or having any claim against the Club, shall look only to the funds and property of the Club for payment of any such contract or claim or for payment of any debt, damage, judgement or decree or any other money that may otherwise become due or payable to them from the corporation of the officers so that neither the members of the Club, the officers, present or future, shall be liable personally therefore.

Section 2. Indemnification of Officers

The Corporation shall indemnify all officers and directors of the Corporation to the full extent permitted by the General Not-For-Profit Corporation Act of the state of Illinois, and may purchase insurance for such indemnification to the extent determined from time to time by the Board of Directors of the Corporation.

ARTICLE IX

Section 1. Amendments to the bylaws

The bylaws may be amended, repealed or altered, in whole or in part, by the membership. Proposals to amend the bylaws must be submitted in writing to the Parliamentarian prior to the start of the business meeting so that it can be placed on the agenda. The Parliamentarian shall read all proposals aloud at the business meeting. The Amendment will lie on the table for at least one month. The Amendment will be published in the next newsletter with discussion to take place at the next month's meeting (the first meeting following the initial reading). Voting shall take place at the next (the second meeting following the initial reading) with no further discussion to take place. A reading shall be made before the membership and may vote thereon. A 3/4 majority of all voting members present or represented by properly executed absentee ballots shall be necessary to pass any such motion for amendment. Voting shall be by ballot.

ARTICLE X

Section 1. Compensation

No member shall receive compensation from the Club for services or duties as an officer, chairperson or member; except for reimbursement of prior approved incurred expenses as approved by a majority of the Board of Officers.

The Governor's N.C.C.C. expenses will be reimbursed upon proof of attendance at meetings. The amount reimbursed will be determined by the Board of Officers at the beginning of each calendar year.

ARTICLE XI

Section 1.

Section 1. <u>Club Expenditures</u>
The Club shall at no time pledge or incur debt for an amount in excess of the current unencumbered amount of cash in the Club treasury.

07/2023- Dues Proposal as discussed at our July club meeting

In March 2023 we amended our Bylaws to add new classes of Membership and clarify some Membership classes that had previously existed. Because of that, we need to make sure all classes of Membership have a "new member" and "renewal" Dues amount associated with them.

We are also proposing an increase to the Spouse dues so that the Spouse pays the same as the Primary member dues since the Spouse is entitled to all the same club benefits as the Primary member (Holiday party, etc). This is a \$10 increase for a Spouse Renewal, and a \$15 increase for a Spouse New Member.

These are NRL club dues only. NCCC dues are not changing.







How to Reset the Oil Life Monitor on a C5 Corvette

After you change the oil in your C5 Corvette, you need to reset the Engine Oil Life Monitor.

- 1. Turn the ignition on, but make sure the engine is off.
- 2. Press the "Trip" button on the DIC so that It displays "OIL LIFE" percentage
- 3. Press and hold the "Reset" button for two seconds. "OIL LIFE REMAIN 99%" will appear on the display.
