WITNESSETH: THAT THE SAID PARTIES, OF THE FIRST PART, in consideration of the

sum of One Dollar and other valuable considerations DOLLARS

to them paid by said parties of the second part (the receipt of which is hereby acknowledged), do

by these presents, Grant, Bargain and Sell, Convey and Confirm unto the said parties of the second

part, their heirs and assigns, the following described lots, tracts or parcels of land

lying being and situated in the County of Jackson and State of Missouri, to-wit:

All of lot 298, Country Club Gardens, a subdivision of land in the city of Blue Springs, Jackson County, Missouri, according to the recorded plat thereof, and subject to the restriction that only one building shall be erected or placed upon said lot, and such building shall never be used or occupied for any purpose except for that of single family private residence exclusively. This restriction shall attach to and run with the land and all titles to, and interests in, the same and shall be binding upon each and every owner and occupant of the same forever. To insure the observance of this restriction of the party of the first part, and any owner or occupant of any of the lots 289, 290, 291, 292, 293, 295, 296, 297, 298, 299, 300, or 301, shall each have the right to prevent the breach thereof by an injunction, mandatory or other, and to recover whatever damages may have been suffered from any such breach.
