Approximately 35 volunteers from the Medina County Juvenile and Probate Court, Community Service youth, the Medina Sunrise Rotary and Build-A-Bear Strongsville-Southpark team members assisted in the assembly of the bears in early December in the Achievement Center cafeteria.

The Help Me Grow program and the Achievement Center have been involved with the Build-A-Bear Project for approximately four years.

"There are some very cool parts to this job," Judge Dunn said after the children received their bears. "This is definitely one of them."

LEADERSHIP MEDINA CO. VISITS DETENTION CENTER

The Leadership Medina County Class of 2014 made a stop at the Medina County Juvenile Detention Center during their Local Government/Safety Forces Day December 11 to learn about the Juvenile Court, as well as take a tour of the detention facility.

Judge Kevin Dunn was scheduled to speak to the class, however, there was a scheduling conflict when the Judge was required by the Supreme Court to attend a class in Columbus. That is when Court Administrator Sharon Danko and Juvenile Court Magistrate Susana Lewis, also a Leadership Medina County Class of 2014 member, volunteered to speak

to the class on the Judge's behalf.

37 members of the 2014 class began their hour-long visit to the JDC at 11:00 a.m. with a video introduction from Judge Dunn. Magistrate Lewis then explained the process of juvenile court, consequences for juvenile offenders and Court programs that juveniles and their parents may be ordered to complete.

"I know I can speak for Judge Dunn when I say we hope everything we do in Juvenile Court helps stop recidivism, or the re-offending cycle," Lewis said.

JDC Superintendent Ron Stollar also spoke to the class about the

maximum security facility before he and Assistant Superintendent Rick Reuss led a tour through the detention center.

"We got a great response from the Leadership class. They really enjoyed learning more about our juvenile justice system and really appreciated the tour of the facility," Lewis said. "It's important that the community becomes more knowledgeable about the juvenile justice system because juvenile crime impacts all of us. By heightening community awareness we can work together to respond to the needs of our community."
