□ Campus Tour – Prospective parents are invited to visit IExcel Preparatory Academy for a campus tour and/or Open House between the hours of 9-11am. Please call the Admissions Office at 305-624-0101 to arrange an appointment as well as meeting with an admissions officer.
□ Application – Please complete all questions on the application and return it to the admissions office one week prior to testing.
□ Recommendations and Records – Please provide a copy of your child's report cards from the last nine weeks
. In addition to this, we require two letters of recommendation per applicant. Enclosed is a form that may be used.
Please Note: Recommendation letters must be sent directly from their current school or be delivered in a sealed envelope. Letters can also be emailed to info@excelkidsacademy.com. At this stage in the application process, we may call your child's school to verify their attendance and discipline records if deemed necessary.
□ Student Application – All students entering Grades 6 – 12 should complete the Student Application and return it attached to his/her application one week prior to testing.
□ Testing – The Admissions Department requires ability and/or readiness evaluations for all applicants. The testing fee is \$100.00. To schedule a testing session, please call. The application, records, recommendations, and student application are due one week prior to testing.

***The Admissions Department will only review your child's application once the requested materials are received and all procedures are completed.

After admission, you will receive an enrollment contract. In order to secure a spot for your child, the contract must be properly executed along with the appropriate deposit made.
