

WAIVER AND RELEASE AGREEMENT

(Please read carefully before signing)

This is a release of liability and waiver of certain legal rights. In consideration for my being permitted to participate in the activities of boating & fishing, I agree to the following Waiver and Release: I acknowledge that fishing has inherent risks, hazards, and dangers, that cannot be eliminated, particularly in a wilderness environment.

I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

- 1. Water hazards in boating and wading in the rivers, lakes and creeks including drowning;
- 2. Injuries from fishing equipment and other participants;
- 3. Encounters with wildlife, animals, and insects;
- 4. Temperature extremes;
- 5. Inclement weather conditions and unavailability of immediate medical attention in the wilderness in case of injury.
- 6. Falling in/out or on the boat and fishing equipment.
- 7. Falling on or off any boat dock. Including boarding and stepping off the boat.

I understand the risks, hazards, and dangers of fishing and have had the opportunity to discuss them with a www.CrappieCatsTV Guide Service representative. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate, and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF www.CrappieCatsTV Guide Service WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH. Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS www.CrappieCatsTV Guide Service, their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of said Guide or www.CrappieCatsTV.com Guide Service or from some other cause.
