# 2024 Myerstown First Aid Unit Subscription Program

## **Coverage**

As before, the 2024 Myerstown First Aid Unit Subscription Program will have two subscription levels.

- Families a family subscription covers any resident of the household listed on the application. Please note: Adults (18+) who move into the household after registration will not be covered under the family subscription; they must register for a subscription of their own. Dependent children added to the household will be covered under their parent/guardian's membership.
- Individuals an individual subscription covers one adult, age 18 or older.

The subscription program coverage is for the calendar year and becomes effective January 1 or the date you enroll, whichever is later.

Note: Due to current laws, we are unable to offer this program to our community members who are on Medicaid or are uninsured.

#### **Benefits**

The Myerstown First Aid Unit subscription program will provide members with a 35% reduction on their out-of-pocket expenses.

### Costs

We are happy to announce that the 2024 program cost will remain the same as the past year.

- Cost for a **Family** \$60.00
- Cost for an Individual \$50.00

#### **Important Notes**

- The subscription program is not a contract for the provision of ambulance services.
- The subscription program only covers emergency ambulance transports which are medically necessary and
  reasonable. It does not cover non-emergency ambulance services or ambulance services which have been or
  should have been pre-scheduled. It does not cover situations where the patient refuses to be transported or
  where the patient or a third party calls 911 for reasons that are not an emergency requiring ambulance
  transportation to the closest appropriate facility.
- Another ambulance service may respond when our ambulance service is unavailable. Alternate ambulance services may but are not obligated to honor your MFAU subscription.
- This is not a solicitation for the offer or sale of an insurance product.
- All subscriptions are subject to acceptance by MFAU and may be canceled or revoked at MFAU's sole discretion. Terms and provisions of the subscription program are subject to change without prior notice.
- The subscriber acknowledges that MFAU will bill available third-party insurance for services rendered and agrees to remit to the ambulance service any third-party insurance payments received directly by the subscriber.
