

## Photographic-Film-Sound Worker, Artist, Show or Model Release

In consideration of my engagement and being filmed, photographed or recorded of which I owe nothing and all costs are born by the photographer, upon the terms herewith stated, I hereby give to Martin and/or Stormy Mongiello (the "Photographer(s)"), his/her heirs, legal representatives and assigns, those for whom the Photographer is acting, and those acting with his/her authority and permission:

a) The unrestricted right and permission to use, re-use, publish, and republish photographic portraits, videos, sounds, film or pictures of me or in which I may be included intact or in part, composite in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction hereof in color or otherwise, made through any and all media now or hereafter known for "illustration, art, promotion, marketing, advertising or trade in relation to the specific appearance or showing of":

b) I also permit the use of any printed material in connection therewith, but only for this event and items thereafter showcasing the event. Any items are NOT AUTHORIZED to pop-up and be used for other campaigns later or other advertising and marketing later if they are not directly related to this event.

c) I hereby DO NOT relinquish any right that I may have to examine or approve the completed product or products or the advertising copy or printed matter that may be used in conjunction therewith or the use to which it may be applied. I FULLY EXPECT to have three rounds of changes afforded to me to review proposed works, marketing or advertising that I suggest. After the third round, posing no illegal violation of criminal or civil law the "illustration, art, promotion, marketing, advertising or trade in relation to the specific appearance or showing of" shall be allowed.

d) I hereby release, discharge and agree to save harmless the Photographer, his/her heirs, legal representatives or assigns, and all persons functioning under his/her permission or authority, or those for whom he/she is functioning, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy. This does not include deliberate libel or deliberate violation of tort, UCC, Droit Moral law. Photographer may utilize my likeness, photo or video in all means of production, advertising, sales, marketing, publicity, branding, promotion and more but may not include me in any pornographic work or feature.

e) I hereby affirm that I am over the age of majority and have the right to contract in my own name. I have read the above authorization, release and agreement, prior to its execution; I fully understand the contents thereof. If a minor, please see my legal guardian or parents signature below. This agreement shall be binding upon me and my heirs, legal representatives and assigns.
