****Travel Fees (On Location):** Includes one stylist/artist and starts at **\$75+** depending on distance. We require a minimum of \$500 in day of services to travel. Additional stylist/make-up artists may result in additional fees.**

Wedding Day Logistics:

On the wedding day, the hair and makeup will be done following a schedule. Every person getting their hair done in an up-do, half-up style, or curls must already have their hair shampooed/blown dry/no product and not styled. If still wet the stylist will charge extra to blow dry (if time permits) or the service will be forfeited and the charge will still apply. The bride must confirm and commit to the number of services stated above. The stylist/artist needs a designated space to set up when on location with available outlets for irons/chairs and table to place products. If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply.

Upon receipt of this contract, the stylist will total the amount that is due on the wedding date as well as provide a detailed schedule to the bride. Should the stylist/artist have a personal emergency that prevents he/she from performing services as agreed, all efforts will be made so that a replacement stylist/artist will be present to perform the contracted services. Should an emergency occur at the last minute that no stylist/artist is available, all fees will be refunded. The stylist/artist will not be held liable for any injuries that should arise while on location.
