Vendors are **NOT** permitted to discharge any grease or water on site. Food vendors with deep fryers **MUST** have an onsite Type 12 Fire Extinguisher required by the State Fire Marshall. There will be inspections.

Both food and booth space vendors are responsible for disposing of their trash at the facilities dump site. Please help us keep the park clean.
