- The group was generally supportive, so Sara-Lyn will do more research and come back.

Project Updates:

- Park
 - o Carl got the second property on Dec 27
 - Looking into equipment and a base.
 - Needs to take trees out. Water district will help with excavator.
 - John McOmber will make benches and tables out of the trees.
 - Carl is looking into other properties to make a trail from Little Big Horn to the top of Sante Fe.
 - o Park will be ADA compliant, the trail will be compliant as far as possible.
 - There is approximately \$21,000 left of the grant fund.
- Communication Hub
 - o They have the editorial person hired and plans in place
 - They are waiting for numbers from Kristi
- World Café
 - Data from the event has been compiled and will be presented in the End of Year report
 - FCA will host a meeting in May with new county leadership including the new sheriff to discuss the results since safety was one of the highest areas of concern.

Networking:

- Board members have been reaching out to other groups to try to increase our attendance, including Thursday meetings at the library and others.
- Jessica Bee will forward the invitation for the Health Fair on May 18
