



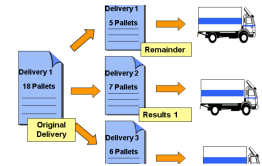

## 3. Scope of Services:

Carrier agrees to provide transportation and logistics services to Shipper as specified in individual shipping agreements ("Shipments"). Details of each Shipment will be mutually agreed upon and documented separately.

## 4. Payment Terms:

4.1 Payment Terms: Payment for Carrier's services is due within seven (7) days from the date of invoice.

4.2 Payment Methods: Payment shall be made via ACH, Wire Transfer, or Zelle, using the banking information provided by Carrier.

5. Pricing:

5.1 Rates: Pricing for Carrier's services is as specified in the individual Shipment agreements.

5.2 Additional Charges: Additional charges, such as detention fees, accessorial charges, or any other agreed-upon fees, will be detailed in the individual Shipment agreements.

5.3 Detention is billed at \$50 per hour after the first 90 minutes at any location our trucks are made to wait past that timeframe.

6. Invoicing:

6.1 Carrier shall provide Shipper with accurate invoices detailing the services rendered, including any applicable charges and fees.

6.2 Shipper shall review and verify the accuracy of each invoice. Any discrepancies shall be communicated to Carrier within three (3) days of invoice receipt.

7. Payment Responsibility:

7.1 Shipper agrees to make full and timely payments for Carrier's services, following the payment terms specified in this Contract and individual Shipment agreements.

7.2 Shipper must send Remittance of payment on or before the final due date (Net 7) in order to avoid late fees.

8. Late Payment:

8.1 In the event of late payment, Shipper shall be responsible for any reasonable collection costs incurred by Carrier, including attorney fees.

8.2 Shipper agrees to be charged a 1.5% late fee per day that the invoice is not paid, unless prior arrangement is made via email only.

9. References and Banking Information:

Shipper shall provide references and banking information as requested by Carrier, which may be specified in individual Shipment agreements.
