## Michigan American Legion High School Oratorical Scholarship Program Winner Announced

Since 1938, The American Legion High School Oratorical Scholarship Program has encouraged the nation's high school students to study the U.S. Constitution and to hone their public speaking skills. The department awards scholarships in the amount of \$2,000; \$1,000 to the top five contestants in the state and national awards scholarships of \$25,000, \$22,500, and \$20,000 to the top three contestants.

Each state winner who competes in the first round of the national contest will receive a \$2,000 scholarship. Participants in the second round who do not advance to the national final round will receive an additional \$2,000 scholarship. The top three youth orators who have won all previous elimination rounds of the contest will vie for top honors in the national competition in May in Hillsdale on the campus of Hillsdale College.

On March 2nd, the Michigan American Legion held our department contest in Lansing at the Michigan Historical Museum. We had a total of four contestants, representing zones one through four. These students were the remaining contestants out of 48 who registered from across the state. Each contestant delivered a prepared ora-

tion as well as an oration on a randomly assigned constitutional topic.

The winner of the contest was Wisdom Love Walker a homeschooled junior from Detroit. Wisdom earned a \$2,000 scholarship from Department for her speech titled "What Happens When the Cameras are Turned on and the 4th Amendment Off". Wisdom will now compete at the National level representing Michigan.

The remaining contestants placed as follows:

\$ 1,500 Second Place Scholarship- Janelle Yao from Portage who is a sophomore at Portage Central High School.

\$1,000 Third Place Scholarship- Evelyn Wells from Troy who is

a senior at Troy Athens High School.

\$1,000 Forth Place Scholarship-Lillian Molitor, who is a home-

schooled junior from Midland.

## Runyan's Ramblings THE NEW POST & SAL CRIME/BOND POLICY

Per the National and Department Bylaws, Post & SAL officers and employees shall be covered by a crime / fiduciary policy that handles American Legion monies.

Over several years, the Department had offered a crime/bonding policy to Posts and SAL Squadrons for \$10 to cover their membership monies. However, this offering is no longer available for the upcoming year or the following years. Since the Department is unable to make this offering, it will be mandatory that a Crime & Fidelity insurance policy is obtained by the Post (which will include the SAL).

WHAT WILL NEED TO BE DONE NOW-Starting this year, there are a few options that can be done to remain compliant. For Posts that do not remain compliant, this could have some adverse effects such as:

1) Posts could have their 2025 membership cards delayed from shipping and

Posts that are not compliant with National and Department Bylaws could be suspended.

**OPTIONS FOR COMPLIANCE-**All

ways need to send a copy of the Declaration page showing this or the amendment to the policy showing this coverage to the Department

• In many cases, Posts with Lounges may already have a policy that covers them for Crime and Theft.

 Posts can obtain their own crime policy for employees and members that handle money. This can be from a local or online insurance company.

Department is also making available a policy provided by NFP, a National endorsed company through the CHUBB Insurance company. It has multiple levels of coverage, and each post can choose how much or as little coverage they require to meet their needs.

### Chaplains Corner

Has the VA Ever Tried Your Patience?

Years ago, a VA doctor neglected to categorize one of my medications as service-connected. I contacted my VA clinic doctor, who said I had to contact the specialist who had written the prescription. So, I used the VA portal to contact that doctor and got crickets in return.

Then, the invoices kept coming. I returned an invoice with a note explaining the error. In return, I received yet another invoice. So my response was to write a letter. All the while, as I was trying to word the letter, my patience was almost nonexistent. The error was finally corrected, and the invoices were stopped.

I must admit I rushed to the point of anger after my first attempt fell on deaf ears. I should have followed the path found in Proverbs 16:32: "He that is slow to anger is better than the mighty, and he that ruleth his spirit

than he that takes a city."

Fast forward to a few months ago. I thought things were fine after my annual visit with my VA clinic doctor and having that same medication renewed. While they were entering the prescription into the computer, I reminded the doctor to make sure it was classed as service-connected. The medication came and was later followed by an invoice. So I thought, not again! This time, I calmed myself down and took a slow, careful look at the invoice. There was a phone number listed to call if there were any questions. I called and politely explained my issue. Within a few days, I received a phone call telling me the problem was resolved. I even got a second call telling me the medication was reclassed to service-connected.

Whether it's the VA or some other source of frustration in our lives, it's a t-shirt, a cap that they color, and a goodie bag filled never a good idea to rush to the nuclear option for a solution. Flag folding, marching, patriotic crafts, cards for Veterans, scavenger hunt, trying on donated old uniforms from various military branches, etc. The instructors are volunteers from the post. Last year, the Coast Guard joined in with equipment for the children to explore. Each child receives with patriotic items and candy. At graduation, each child receives a certificate of completion.

They gather donations from various businesses and individuals to cover the costs of food and supplies. They promote this event with flyers and registration forms to the grade schools, flyers to local businesses, and social

media.

### Service to Veterans

Service to Veterans volunteers are American Legion Auxiliary members who provide service to veterans outside a VAMC (Veterans Administration Medical Center)

Whether organizing a stand down, assembling care packages/tray favors/greeting cards, assisting with a veteran's burial or gravesite upkeep, sewing, cooking, or shopping for active-duty military/veterans and their families, member volunteers are at the heart of the Veterans Affairs & Rehabilitation Program structure.

Many of our veterans need assistance around their homes. Elderly or limited-mobility veterans may not be able to take care of all their housekeeping requirements

and would appreciate some extra help.

Knowing that veterans and current servicemembers do not always ask for help in times of need, your local American Legion Auxiliary is a great place to look for assistance in locating veterans who may need some help at home.

Often, organizations or individuals aware of a veteran's issues will encourage those in need to share their information with the local American Legion Auxiliary unit. In this manner, volunteers can be matched with veterans in need of assistance.

Ways to Help Veterans at Home:

- Basic home tasks or repairs (i.e., painting a room or the exterior of a house, assembling a shelf, programming electronic devices or computers, hanging picture frames).
- Yard work (i.e., snow removal, raking leaves, weeding, mowing the lawn, brush cleanup).
- Build a wheelchair ramp for a veteran who has lost a leg or an elderly veteran who is less mobile.
  - Cook a meal for them at their home.
  - Do their laundry or house cleaning.
  - Drive them to and from appointments.

Now it's your turn!

- Find a veteran. Ask organizations or volunteer groups if they know of anyone you can help.
- Ask friends or family members to help. Two people

can help tackle more projects.

 Follow up. After you complete the project, check back with the veteran and see if there is anything else you can do (i.e., if you mow the lawn, see if it needs to be mowed again in a few weeks).

Share your experience to encourage others to find

ways to help veterans.

Remember to keep track of your volunteer hours. You can claim 10 hours a week if you live with the veteran and 5 hours a week if you do not live with the veteran.

## Handling ALA-MIS

In the last couple of months, we have been experiencing our first round with ALA MIS renewals, rejoins, and new access. Sara and I have handled all the phone calls, emails, and documentation related to this very useful program provided by National. It has been quite a stressful

time for both of us, but we are being educated and learning every day. Moving forward, we will provide two reminders prior to the 2025 access year. One in October and another in November.

Some questions and issues we have seen repeatedly. Such as, if you sign up for ALA MIS and you get an email from National, please read it in its entirety. There is almost always a link to click to move forward. You may have to participate in some training (even if you already have), take a quiz (even if you already have), etc.

The only difference between unit write and unit full is being able to process your own membership. If your unit does not have a debit or credit card to process your membership, you do not need unit full access; it is a waste of money to upgrade if you cannot use it.

When representatives change positions and a new person takes over ALA MIS access, send the form to the Department so the change can be made. Don't pay another fee unless it's the end of December. If someone leaves your Unit, report it so their access can be deactivated. The Department is charged for all users listed on the National's database as a current user. Even if the person no longer needs access or uses ALA MIS, if National says they have access, then the Department must pay.

As I mentioned during the 2024 Winter Meeting, adequate training for this program is scant. My suggestion is that units and districts get together and have training opportunities led by members who are most familiar with and experienced with the ALA MIS system. Please try to resolve problems on your own before calling the Department. Please remember that Sara and I are new to this organization, and we need all of the grace you can provide.

In closing, if you haven't already renewed your ALA MIS access and you want to, please get the paperwork into Department as soon as possible. Thank you for your support and continued efforts in assisting our Veterans.

These juniors are fired up and enjoying the mentoring they receive from their senior membership. I can't wait to see all the great things they accomplish now that they have their feet under them. Every Unit should encourage junior participation. If you don't have juniors, contact the local high schools. Many young people are just waiting to answer the volunteering call, but we must call them!

As you may know, Abbie's platform this year is "May the Force be with our veterans," and her special project is Guardian Angels Medical Service Dogs. Abbie chose this organization because her Uncle Johnny was one of the 22 veterans a day we lose to suicide, and she feels if Johnny had a service dog, he would still be alive today. Statistics show veterans who have service dogs have a 0% suicide rate; these dogs save veterans' lives!

I was recently reading a story from the founder of Guardian Angels, and she recounted a story from when her father, a Korean war veteran with PTSD (and other war-related issues), was dying. He had dementia and did not know her or her mother, but his service dog was still by his side. She reached out and nudged and licked his hand; her father responded to his dog by patting her head and saying, "You've been a good dog to me." Shortly thereafter, her father passed away. What a story! In his dying moments, when he knew no one or nothing around him, he knew his dog. That says a lot about how important these dogs are, the bonds created, and the difference they make in the lives of the Veterans. The importance of this project is immeasurable. I implore you to help Abbie raise the funding for the two Michigan veterans currently waiting for dogs.

The Department of Michigan has just over 28,000 members, so if every member paid \$2.00, we would have more than enough funds to cover both dogs. Every Unit and District President has received an email from me. Thank you to the 40 Units, 1 Squadron, 2 Posts, 3 Districts, and several individual members who answered that call; because of each of you and your commitment to this cause, we are well on our way to achieving this goal! ## **Legislative Update**

American Legion Auxiliary members have been participating in legislative activities in various ways while following the objective to promote and support The American Legion's priorities/agenda. This time of the year is typically the busiest for legislative work at the state level. The State of Michigan meets for approximately 28 weeks, primarily from January to June. Nationally, legislative work is done year-round, with Congress meeting 168 days in 2023.

The American Legion's Legislative Center web page is a valuable information resource. The Dispatch also provides information. The American Legion Auxiliary's Advocacy Guide explains how to be an advocate starting at the grassroots level. If you would like this pamphlet, contact me, and I will get it for you.

The American Legion believes funding-related issues will be the most important in the coming months. The fiscal year 2024 Department of Defense budget proposal has anticipated changes in retirement, healthcare, and other benefits. Curbing the jobless rate of veterans (nearly 250,000 veterans are currently unemployed) and flag protocol are also high on the list.

When soldiers on the front lines were asked what The American Legion could do for them, they replied that their greatest concern was not for themselves, their safety, comfort, or supplies, but rather to take care of their families, their retirement,

and their GI benefits. This is our legislative responsibility as we vigilantly make our position clear to our legislators, reminding them of our priority to ensure veterans the care and benefits they so surely deserve.

The following are policy priorities for the 118th Congress: Protecting the VA and the Department of Defense from funding reductions, continuing the VA home loan project, implementing the Disabled Veterans' tax, and protecting our flag from acts of desecration.

As Congress discusses and decides on these issues, keep your legislators informed of our position. This year, even more is at stake as we look forward to primary and National elections. We have the freedom to vote. We have a voice in who our government officials will be. Let us never take that for granted. We can make a difference. "Every vote counts". The first step is knowing when your elections are being held. Next, know who you are voting for and then how to vote, either in person or by absentee ballot.

Michigan voters now have the right to vote early in every statewide and federal election. Early voting is offered at least nine consecutive days before the election for at least eight hours a day. Absentee voters can also sign up to become permanent mail voters. They will receive an absentee ballot before all future elections, making voting more accessible for all absentee voters. These are all efforts to make voting easier and obtain more voter participation. "Your Vote Matters."

## **NEC Report**

As the National Executive Committee member, I bring greetings to all Michigan members from the National organization. The National Executive Committee (NEC) is the governing body of the National organization, just as the Department Executive Committee (DEC) is the governing body of a Department. The voting members of the NEC are the 11 National officers and a representative of each of the Auxiliary's 52 Departments. Each Department has an NEC and an alternate NEC. Each Department has its own rules for electing its representatives to the NEC, but in Michigan, according to the Department Constitution, Article IV – Department Officers, Section 1c, "The retiring Department President shall be declared elected as National Executive Committee member for the year immediately following the term as Department President. If the retiring Department President is unable to serve as National Executive Committee member for the year immediately following the term as Department President, a Past Department President shall be elected to serve the term."; and 1d, "The incoming Department President, shall be declared elected as Alternate National Executive Committee member for the year of the term as Department President."

Members of the NEC Meet in person at a pre-convention Meeting (National Convention) and a post-convention Meeting. The pre-Convention Meeting is to wrap up any business from the year that is concluding. The post-convention Meeting is to ratify Committees and other appointments and inform members (many of whom are new to the position) of any ongoing investigations at the National level. Just as with our Department meetings, the regularly scheduled meetings are open meetings but there are also closed-session meetings to discuss items of a sensitive nature.

Closed-session meetings are highly confidential.

For the 2023-2024 year, I attended an informational "NEC 101" meeting conducted by Chris Dickey, the Registered Parliamentarian retained by the American Legion Auxiliary. This was held at the conclusion of the National Convention in Charlotte, North Carolina, and immediately preceding the post-convention NEC meeting. This was to prepare members for what to expect during an NEC Meeting. NEC members were reminded that in their position, they represent the interests of the national organization and not the individual Departments from which they come. The newly elected National President, Lisa Williamson, conducted the NEC Meeting after the training. After the regular business was conducted, the NEC went into a closed session.

A special closed-session NEC meeting was held virtually on November 29, 2023. Again, a pre-meeting review and Q&A session on NEC procedures relating to this meeting was conducted by the National staff and Chris Dickey. This was also held virtually. Two NEC meetings were held virtually on February 24 – one in closed session and the other as our Mid-Winter NEC Meeting. Again, a pre-meeting training and Q&A was held virtually a few days before the meetings.

At the general meeting, the National President, National Secretary, and National Treasurer gave their reports for the 2023-2024 year thus far. President Lisa stressed the importance of the "Be the One" initiative, which is a Legion Family Mission. It was noted that the Mission Trainings/ National Junior Meetings held in each Division were very well attended this year, showing an interest in improving and growing our organization.

The Risk and Compliance Committee, along with representatives of the independent auditing firm Blue & Co., LLC, gave a detailed report of the financial position of the National Amer-

ican Legion Auxiliary for the year ending September 30, 2023, and a comparison to the previous year ending September 30, 2022.

The information presented shows that the operations of the national organization are being conducted in a sound business manner, and smart decisions are being made by the administration. The organization is financially healthy as we move forward with the same high level of professionalism, regard, and passion for the programs we currently have and those of the future. This allows the organization to expand on such things as the number of scholarships being given as well as other items. Membership has finally experienced an upswing in numbers after several years of decline.

One of the committees appointed by the National President for their administrative year is the Minutes Approval Committee. This committee is charged with reviewing the minutes of meetings held by the NEC and Convention for accuracy and completion. That review, when approved, is reported as approved to the NEC at the next meeting. The minutes of regular meetings are then posted on the National website for any member to see. They can be found under Meetings/ Proceedings at alaforVeterans.org. Having such a committee eliminates the need for the entire group to hear/ read the minutes for approval months after the meeting occurred.

As a personal comment, I found that the training/Q&A sessions held before each meeting were very informative and have helped the meetings run smoothly as questions may be asked beforehand on such things as when a motion will be necessary, how to make the motion, when such discussion is out of order and when a vote will be required. It has been my honor to represent the Department of Michigan as the 2023-2024 National Executive Committee member.

## Legislative Report



**Tim Poxson** Legislative Chairman

Before I get into the work, the Legislative Committee has been doing. I want to remind everyone that we are heading headlong into the election cycle. I will list some things you and your post cannot do during the election cycle. The American Legion is nonpolitical and may not promote the candidacy of an in-

dividual seeking public office.

1. You cannot wear any American Legion gear at political functions or in photos with anyone running for a political office. This includes your cover.

2. You cannot post political signs in or on your post prop-

You can have candidates coming to your post to give speeches if you remove all Legion-identifying flags wall coverings and no one wears American Legion gear. If your post has one side come into the post, you should make every attempt to have the other side come in too. Your post still cannot endorse any candidate, or promote any candidate in writting.

The Legislative Committee has been busy with the priorities already in place. Some of our priorities have already been enacted into law and others are awaiting Committee hearings in the House or Senate. The committee presented four resolu-

tions to the DEC at the Winter Meeting in Flint.

24-2 Claims Filed by Accredited Service Officers for Veterans in Michigan. This resolution calls for only those who are accredited by the VA to be able to assist or file claims for Veterans in Michigan other than the Veterans themselves. It also asks for legislation to make it illegal to assist a veteran by those not accredited by the VA.

24-10 Objecting to HB 5227 or similar Legislation that would outlaw mechanical amusement devices that are currently legal. This would outlaw devices like "Nudgemasters." The Resolution requests the Michigan Legislature to enact laws to ensure these types of devices are written into law as being legal.

24-11 Support the expansion of Charity Gaming HB 5085 or Similar Legislation. This seeks to expand the use of certain pull tab machines that are currently in use at a small number of posts on a trial basis. This is not the current paper pull tabs that many posts already have. The machines are more mechanical and provide all the documentation necessary for the Charitable Gaming Commission reports. The return to the trail post has been much higher than most of the paper pull tab machines now. No post will be required to give up the paper pull-tab machines they now have, and they may have both as the bill is

24-12 Support Funding to Reimburse Local Units of Government. Currently, local units of government are not reimbursed for their loss of tax revenue from giving qualified Veterans an exemption for paying property tax. The Michigan Constitution requires local units of Government to be reimbursed for loss of revenue from State mandated programs enacted after 1963. The Property Tax Exemption was enacted in 1973 without giving local units of government back their lost tax based on the exemption. This needs corrected before a local unit of Government or its association sues the state on this issue. This resolution pointed out two potential sources of funding and while we are sure there are other opportunities for the State to find the money, they have been reluctant to do so as of this date.


