



Why the Michigan American Legion is Important to Your Community

There is one tool we ask each Post and Squadron to use every year, which seems to be ignored or forgotten. This tool or document is the Consolidated Post

Report (CPR) or Squadron Data Report (SDR). The state sends these forms out to every Post and SAL every year in late

March or early April.

This document is very important to your entity, the state and most importantly to the US Congress! That's right; the US Congress and the lawmakers in this great nation will get raw data and numbers on what we collectively do in our state. Now, you might be scratching your head thinking...Ron, why do they care? Well, that's a great question. They see the importance of why we belong, why they allow The American Legion to be a Congressionally Chartered organization, and why we are a 501c19 Tax Exempt organization. They see the countless hours our volunteers put in at VA Hospitals. To put this one item into retrospect, if the federal government had to employ people to do what our organization does volunteering, it would cost millions of dollars more every fiscal year, and that is per hospital. So, there is a massive benefit for us to continue doing our volunteer work, but most importantly letting them know what we are doing. Check out this article, "By the Numbers," which breaks down the information from CPRs/ CSRs: https://www.legion.org/bythenumbers. THIS MAY BE THE REASON SOMEONE BECOMES A MEMBER OR REMAINS A MEMBER!

The form can be intimidating for many of our Posts and SAL squadrons. It is true that it is lengthy. However, answer every question to the best of your ability. To make it easier next year, try to document areas within the form throughout the year. Use your best judgment when answering or your best guess, but be as realistic as possible. If nothing else, once it is completed, make sure the top portion is filled out fully with your post information and membership numbers, and send it back to Department HQ by early June. Our staff will scan and email these to the National organization to have them recorded.

As of mid-April, Michigan only had 6% of all Posts with the CPRs turned in. I would like to see posts and squadrons get up to or exceed 80% CPR/CSR turn-in percentages. All current and past leadership and other involved members should be taking the initiative and calling to help get these forms filled out and turned in.

Membership Report

CONGRATULATIONS TO ALL POSTS AND DISTRICTS. THE DEPARTMENT HAS HIT THE 95% TARGET DATE.

The Department has not reached the 95% target for at least a decade, and we have now made every target date so far this year. We have only the 100% target to make on May 15.

The Membership Committee this year has been successful. We changed the form of the committee from the District First Vice Commander being on the Committee to five members selected for their expertise in a particular area of membership growth.

The committee has met every month to discuss our growth plan and has continued to work on the plan throughout the year. In September, the Department started in 22nd place in the National Standings and rose steadily until we were in the top 10, reaching 5th place in January.

We are in 1st place in the Central Region, and we now have 81 Posts at 100% or higher, 12 Posts that have achieved at least 98%, and 49 Posts at 95% or above.

The Post Development Subcommittee has had an active year with the revitalization of Walker Post 1111, canvassing 225 members in their area and had a VSO present to handle any claims for the VA. Post 1111 is now at 100%.

At the Winter Meeting, the DEC closed the East Detroit/Roseville Post 261, with most of their members and assets transferred to nearby Mt Clemens Post 4. The DEC has voted to close Inkster Post 285 in District 16. It will now go to the National Executive Committee for approval at their Spring Meeting.

A new post was started in the 3rd District, the David Nims Post 420, which has received its temporary charter and is well on its way to its permanent charter

I want to thank everyone who has worked so diligently to make this year successful. What You have achieved is simply phenomenal.

Thank you for allowing me to serve as your Membership Director this year. It has been an honor and a pleasure.

It has been a very busy year here at MVH of Chesterfield Township. The doors are open, and volunteers are welcome, creating an enjoyable environment for the members of the home. Poppy assembly started in July, and we had one veteran of the home who began assembling his first kit. The program has evolved to veterans joining me in a discussion about the poppy as I assemble them, and a few attempt to finish a poppy, and a few succeed. I also assembled poppies while handling the reception desk in the evening. To date, 40,000 poppies have been assembled in honor of veterans and turned in through this program.

We have supplied needed clothing for veterans who have arrived with very little or no changes of clothing, robes, slippers, and shoes—also, items requested for therapy and recreation. We have stocked the canteen with beverages and snacks on several occasions. Many wish list items have been purchased and delivered as approved by the DEC.

"Adopt A Veteran"-Units and Juniors have adopted veterans and receive special attention and care throughout the year, and it is appreciated. We have a waiting list of veterans to be adopted. If you, your unit or your district would like more information about adopting a Veteran, please contact me, and I will assist you.

Receiving cards from the "Cards for Soldiers" program

has been nice. Various Thinking of You, Birthday, Feel Better, Holidays Christmas, Valentine's Day, St. Patrick's Day and Easter Cards are given to our members. Send a letter, note or postcard whenever they all love getting mail.

We purchased candy for Halloween as members participated in a Trunk or Treat at the local elementary school across the street. They were adorable Dalmatians, and staff members dressed as Cruella de Vil. They also had trick-ortreating in the home.

Our first annual Christmas Shop was held in November; Units #4, #63, #108, #143, #149, #216, #351, #377 and #382, the 7th and 18th District all donated money and gifts with a total value of over \$10,000. Eight volunteers helped set up, and 11 for a shopping day and clean up. It was a success.

The Valentine's Day Party was a big hit. Unit #510's donation of \$250 went towards the band and snacks. We had five energetic volunteers from the 7th and 18th Districts that afternoon.

PROPOSED AMENDMENT 24-CA-1

A proposed change to the Department Constitution, Article IV, Section 2. which now reads:

"There shall be no form or class of membership except an active membership, and dues shall be paid annually or for life." To be Amended by: Changing the limited options for amount of time of paying dues to reflect the recent change by National authorizing three (3) year membership and to also allow for possible future dues paying option that may be authorized by National.

So that when amended, Article IV, Section 2, shall read: "There shall be no form or class of membership except an active membership and dues shall be paid as prescribed by the National organization".

<u>REASONING:</u> Licensing and Regulatory Affairs agency of Michigan requires each nonprofit corporation of Michigan to have at least three (3) directors. With the defining requirement within the proposed amendment, this requirement can be met by all Posts of the Department.

Newly elected Post Officers shall be installed not later than forty-five (45) days after the close of the annual Department Convention, and all Post Officers shall have paid their dues for the year of their term of office by the time of their installation".

Said Call shall, at the same time, be mailed in letter form to each member of the Department at their most current mailing address and shall include any proposed amendments to the Department Constitution and Bylaws. There shall be no other official notice of the Department Convention."

Unless the Administrative Committee shall, by a fourfifths vote of all the members, find the complaint to be without merit, the matter shall be referred to the Department Executive Committee."

"It shall be the duty of the Commander to forthwith call a special meeting of the Executive Committee to convene within twenty (20) days thereafter to consider and act upon the complaint. Upon failure of the Commander to call such a meeting within a period of five (5) days after the complaint shall have been referred to the Executive Committee by the Administrative Committee, any other officer of the Department shall be authorized to call such meeting. The Executive Committee shall, by resolution, determine the manner in which such complaint shall be heard and action taken thereon. The action of the Executive Committee shall be final and conclusive." To be Amended by adding new wording:

So that when amended, Bylaws, Article XI Discipline. Section 1, shall read:

Article XI DISCIPLINE OF DEPARTMENT OFFICERS "The Executive Committee may, by two-thirds vote of its members, remove from office any officer or committee member of the Department for malfeasance, misfeasance, or nonfeasance in office or for conduct unbecoming a member of The American Legion. Complaints seeking removal of such officer or committee member shall be reduced to writing, signed by a member of the Department of Michigan, and verified by oath that the charges therein contained are true of the member's own knowledge. Committee shall, by a four-fifths vote of all its members, find the complaint to be without merit, the Administrative Committee will move forward with the matter."

"It shall be the duty of the Department Commander to forthwith call a special meeting of the Administrative Committee to convene within twenty (20) days thereafter to consider and act upon the complaint. Upon failure of the Commander to call such a meeting within a period of five (5) days after the complaint shall have been referred to the Administrative Committee, the Judge Advocate will refer the matter to the Department First-vice Commander who shall be authorized to call such meeting. The Administrative Committee shall determine the way such complaint shall be heard, and action taken thereon. The action of the Administrative Committee shall be final and conclusive, except when the accused takes action to appeal the decision made by the Administrative Committee. An appeal by the accused must be received within twenty (20) days of the final decision by the Administrative Committee."

"If and when the accused appeals the decision of the Administrative Committee, the Department Commander shall call a special meeting of the **Department Executive Committee within twenty** (20) days of the receipt of the written appeal addressed to the Department Executive Committee, through the Department Commander, unless the Department Commander be an interested party or necessary witness, in which case the Department First-vice Commander shall take the request for appeal. The Department Judge Advocate will chair the appeal. The Department Commander, or Department First-vice Commander, if sitting in for the Department Commander, will make every effort to convene the Department Executive Committee within the twenty (20) days of receipt of the appeal. The accused is to appear before the Department Executive Committee during the appeal to present any additional evidence and to answer questions from the Department **Executive Committee. The Department Executive** Committee will make a final decision within ten (10) days of the close of the appeal meeting. The Department Judge Advocate will write and send a letter to the accused of the results of the Department Executive Committee's appeal decision which shall be final and conclusive.

The 2nd Vice Commander shall be the Department Americanism Committee Chair and responsible for the promotion and fulfillment of Department Americanism Programs (i.e.: Boys State, Junior Shooting Sports, Student Trooper, Law Enforcement/Fire Fighter/Eagle Scout of the Year, etc.) They shall assume the duties of the Department 1st Vice Commander when necessary."

PROPOSED AMENDMENT 24-CA-23 A proposed change to the Department By-

laws, Article V. Section 4, which now reads: "Department Zone Commanders shall perform such duties as may be required of them by the Department Commander or the Department Executive Committee. For the purpose of administration by the Zone Commanders, the various Districts shall be grouped into "Zones." The Zone Commander representing each "Zone" shall represent the Department in the Districts comprising the "Zone" from which they were elected, and it shall be their duty to attend all District Conventions within their "Zone", so far as possible, and to initiate constructive programs and policies for the furtherance of the interest of the Posts therein. The Zone Commanders shall not be eligible to serve two (2) consecutive years. The Districts and Zones will be determined by the Department Executive Committee and published in the DEC Manual each year."

To be Amended by: Rewritten for clarification and remove duplication so that when amended, Bylaws, Article V, Section 4, shall read: "Department Zone Commanders: The Department Zone Commanders shall perform

partment Zone Commanders: The Department Zone Commanders shall perform such duties as may be required of them by the Department Commander or the Department Executive Committee. They shall attend all District Conventions within their Zone, so far as possible, and to initiate constructive

programs and policies for the furtherance of the interest of the Posts therein. The Zone Commanders shall not be eligible to serve two (2) consecutive years. The Districts and Zones will be determined by the Department Executive Committee and published in the DEC Manual each year."

PROPOSED AMENDMENT 24-CA-24

The Department Adjutant shall be given an Annual Effectiveness Evaluation by the Department Commander forty-five (45) days prior to the Department Convention. Said Effectiveness Evaluation shall be reviewed by the Department Administrative Committee for filing and/or necessary action. The first Employment Contract shall be for a period of three (3) years, commencing January 1, 1987." To be Amended by: Consolidating and rewording both articles as a new Department Bylaws, Article V, Section 5, eliminating Section 13 So that when amended, Bylaws, Article V, Section 5, shall read:

"Department Adjutant: The Department Adjutant shall be an employee of The American Legion, Department of Michigan, and shall be the chief administrative officer of the Department. They shall be the custodian of and shall cause to be kept all official Department records. The Adjutant shall be ultimately responsible for all administrative and clerical

acts necessary to conduct the business of the Department. They shall receive all dues and monies from Posts and all sources due to the Department, keep a record thereof, and shall deposit the same in the name of "The American Legion, Department of Michigan" in a bank or banks as ordered by the Finance/Personnel Committee, with the approval of the Department Executive Committee. The Adjutant shall perform any other duties as may be directed to do by the Department Commander or the Department Executive Committee."

"The term of office for the Department Adjutant shall be three (3) years, on a contractual basis renewable at the end of three (3) years, as long as said Department Adjutant's service is satisfactory and acceptable. The Department Adjutant shall be given an Annual Effectiveness Evaluation by the

Department Commander forty-five (45) days prior to the Department Convention. Said Effectiveness Evaluation shall be reviewed by the Department Administrative Committee for filing and/or necessary action. The first Employment Contract shall be for a period of three (3) years, commencing January 1, 1987." "The Department Adjutant shall be hired by the Department Administrative Committee. The Department Adjutant shall receive such salary as shall be fixed by the Finance/Personnel Committee, subject to the approval of the Department Executive Committee. The Department Judge Advocate, by and with the approval of the Commander and the Department Executive Committee, shall appoint such Assistant Judge Advocates as may be necessary. torian shall prepare a history of this Department during their term of office and shall submit such history to the Department Convention. They shall collect such other information as may be required to complete the History of the Department from its inception. They shall receive compensation for monies spent conducting their assigned duties."

PROPOSED AMENDMENT 24-CA-28

Sergeant-at-Arms shall be empowered to appoint such Assistants as may be necessary to carry out his/her duties, with the approval of the Department Commander and Department Executive Committee."

Unless the Administrative Committee shall, by a four-fifths vote of all the members, find the complaint to be without merit, the matter shall be referred to the Department Executive Committee. It shall be the duty of the Commander to forthwith call a special meeting of the Executive Committee to convene within twenty (20) days thereafter to consider and act upon the complaint. Upon failure of the Commander to call such a meeting within a period of five (5) days after the complaint shall have been referred to the Executive Committee by the Administrative Committee, any other officer of the Department shall be authorized to call such a meeting. The Executive Committee shall, by resolution, determine the manner in which such complaint shall be heard and action taken thereon. The action of the Executive Committee shall be final and conclusive."

To be Amended by:Rewritten for clarification. So that when amended, Bylaws, Article XI, Discipline, Section 1, shall read:

The Department Executive Committee may, by two-thirds (2/3) vote of all its members, remove from office any officer or committee member of the Department for malfeasance, misfeasance, or nonfeasance in office or for conduct unbecoming a member of The American Legion. Complaints seeking removal of such officer or committee member shall be reduced to writing, signed by a member of the Michigan Department and verified by oath that the charges therein contained are true of the member's own knowledge. Such complaint shall be immediately referred to the Department Administrative Committee, which shall cause the matters therein set forth to be investigated by the Department Judge Advocate, unless the Judge Advocate be an interested party or necessary witness, in which case the Department Commander or the Department Administrative Committee shall appoint a special Judge Advocate for such purpose. Upon failure of the Department Commander to call such a meeting within a period of five (5) days after the complaint shall have been referred to the Department Executive Committee by the Department Administrative Committee, any other officer of the Department shall be authorized to call such meeting. The Department Executive Committee shall, by resolution, determine the manner in which such complaint shall be heard and action taken thereon. The action of the Department Executive Committee shall be final and conclusive.

PROPOSED AMENDMENT 24-CA-34

A proposed change to the Department Constitution, <u>Article XVI</u>, <u>Amendments</u>. <u>Section 3</u>, which now reads:

PROPOSED AMENDMENT 24-CA-35

"No Legionnaire may be appointed to serve on more than one regular standing appointive Department Committee at any one time." To be Amended by: Removing Section 6 and renumbering subsequent sections.

A proposed change to the Department Bylaws, <u>Article VI</u>, <u>Committees. Section 7</u>, <u>which</u> <u>now reads:</u>

Finance/Personnel Committee: "The Commander shall appoint, subject to ratification by the Department Executive Committee, a Department Finance/Personnel Committee to be composed of five (5) members, one (1) member to be appointed from each Zone of the Department and two (2) Alternate members, without vote. The Commander and Finance Officer shall be ex-officio members of this committee, with vote, the Director of Veteran Affairs and Rehabilitation shall be an ex-officio member of this committee and the Adjutant shall be ex-officio Secretary of this committee, without vote."

To be Amended by:

The Commander and Finance Officer shall be ex-officio members of this committee, with vote, the Director of Veterans Affairs and Rehabilitation shall be an ex-officio member of this committee and the Adjutant shall be ex-officio Secretary of this committee, without vote. The appointment of one (1) member from each Zone is preferred, but not required."

PROPOSED AMENDMENT 24-CA-37

I urge each district member to consider adopting a veteran and extending a helping hand. It doesn't require grand gestures; even the smallest acts of kindness can make a difference. By recommitting ourselves to our mission, we can honor the sacrifices of those who have served and ensure that they receive the support and recognition they deserve.

As we move forward, I encourage you to revisit our mission statement and reflect on its significance. Let us rekindle our sense of purpose and rededicate ourselves to the noble cause that unites us all. Thank you for your attention to this matter, and I look forward to working with you to uphold the values that define our organization.

DO YOU HEAR ME?

Julie Becker, VA&R Chairperson

How often have you said that or been asked that question? Now, I would like you to put yourself in a veteran's point of view. The person you talk with may be listening, but do they HEAR you? The statement "you can't understand" is made (a verbal stop sign), yet the other person keeps talking. Do you feel as if you have been heard?

One problem for many veterans is that very few people have the emotional strength to listen to them talk about what they went through. Their feelings of isolation and poor relationships with others are, in part, from having bad experiences with people who are poor listeners. People who have distressing experiences will usually talk with a good listener who will take the time to HEAR their whole story. If you are willing to listen to a veteran speak truthfully about their experiences, here are some things you can do:

1. Don't ask about a person's experience unless you can handle honest answers. When combat veterans returned home, they found that very few people had the emotional strength to listen to their stories. Don't let someone open up only to "chicken out" when the story

gets rough.

Give the person time. Researchers working with veterans found that the average person could listen fully for only several minutes. When a veteran is willing to talk to you, allowing them plenty of time to talk is important. Don't interrupt to state your feelings. Plan to listen as long as needed.

3. Be an active listener. Ask about feelings. Ask questions when

you feel puzzled about facts or incidents.

4. Remain quiet if they start crying. Please don't suggest a better way to look at it. Leave their thoughts and feelings alone. Your quiet presence is more useful than anything else.

Listen with empathy but minimize sympathy. Survivors of traumatic experiences talk more easily to a person with calm concern. Don't make the veteran have to handle your emotional reactions as well as their own. If you need emotional support, seek it elsewhere.

6. Ask if they see something positive about being in combat. Research shows that those who served in combat became significantly more mature and developed a healthy personal identity. The same extreme circumstances that cause emotional trauma for some people cause others to become stronger.

Veterans have important—essential—stories to tell. We all need to hear them.



The Fisher Houses are available to families/caregivers of active duty service members and Veterans seeking medical treatment at VA hospitals or are receiving care at a local hospital authorized by the Veterans Health Administration (VHA) under VA Community Care. Fisher House guest suites each have a private bedroom and bath. There is a shared common kitchen, laundry area, dining room, living room, library and toys for children. All homes are professionally furnished and decorated and are wheelchair accessible.

There is currently a Fisher House in Ann Arbor, and one is being built in Detroit. My wife and I have been utilizing the Fisher House in Cleveland, Ohio, while receiving treatment at the Cleveland Clinic. It is located about a mile away on a shared street. It isn't easy to find inexpensive motels in the area; we had previously been staying at least 20 minutes away.

For Veterans and active duty service members experiencing complicated care plans or seeking a second opinion of their diagnosis, the Fisher House may make that easier. Individuals requesting a Fisher House stay must be referred via electronic consult by a member of the Veterans VA health care team (Physician, Nurse Care Manager, Social Worker, etc...). If a Veteran or family member/caregiver has any questions about Fisher House eligibility, they can always reach out to the Fisher House staff for more information.

For typical circumstances, the health care available to us locally is outstanding. My experience has involved complicated diagnoses, and I've found the level of experience at larger hospitals and the large number of similar cases they treat often translates to better care for Veterans. However, we may be resistant to that option because of the cost of traveling and temporary housing. For Veterans, Fisher House has solved the temporary housing problem and done so with care and dignity.
