**Warning:** Keep in mind, Chapter 7 bankruptcy information stays on your credit report for 10 years (and Chapter 13 bankruptcy for 7 years). This can make it hard to get credit, buy a home, receive life insurance, or get a job.

**Note:** An individual is entitled to one free copy of his/her/their credit report every 12 months from each of the three nationwide credit reporting companies.
