FIG Code of Points (Version"2022-2024 MAG CoP") and this document will be used for all NCAA Gymnastics competitions (https://www.gymnastics.sport/site/rules/#2).

Skill Committee updates - These are NGJA Interpretations only and are based on USA interpretations of the current FIG Code of Points.

The NCAA Men's Gymnastics Committee has authorized a skills evaluation committee to interpret skills and publish interpretations for use in NCAA competitions. This document lists those evaluations. Skills not previously evaluated must be submitted prior to major competitions for review. If a skill is not evaluated by the committee in advance of a competition, a provisional value may be given prior to the start of the competition.

Changes from a previous version of this document will show "***" in front of the interpretation. Depending on how often elements are submitted, this document could be updated frequently. Please monitor NGJA.org for new versions of this document.

General Information

1. *** On December 4, 2022, the FIG released Newsletter #2 with new and updated rules to the FIG COP. https://www.ngja.org/wp-content/uploads/2022/12/Newsletter-2.pdf
Per the NCAA Men's Gymnastics Rules Modification Document, (#1.F, page 4), dated October 1, 2022, "The cutoff date for changes to the NCAA rules and clarifications, which uses the FIG Code of Points as its basis is December 1. The NCAA Men's Gymnastics Committee will review interpretations to the FIG Code received after this on a case-by-case basis, and reserves the right to adopt changes that are in the best interest of the gymnast."

In compliance with that ruling, the Committee reviewed that update and approved adoption of rule updates it felt benefited the athletes. The following table denotes which rules in FIG Newsletter #2 have been adopted and which have not for the 2023 NCAA competitive season.

FX: Spindle to Handstand	Adopt	This is a rule clarification, not a rule change
PH: Scissor to Handstand	Non - adoption	Rule change does not benefit the gymnast
SR: Start of Exercise	Adopt	This is a rule clarification, not a rule change
SR: Balandin Elements	Adopt	This is a rule clarification, not a rule change
HB: Start of Exercise	Adopt	This is a rule clarification, not a rule change
HB: Straight Tkatchev - Definition of position	Adopt	This is a rule clarification, not a rule change
HB: Grip Changes	Non - adoption	Rule change does not benefit the gymnast
SR: Element Value – Zou	Adopt	New element added to COP
SR: Element - Simonov	Adopt	New element added to COP
SR: Element - Garcia	Adopt	New element added to COP
HB: Element - Faulk	Adopt	New element added to COP
