Section 1 – Fully Invasive Refurbishment

Fully invasive internal & external (full prep & paint) Refurbishment of L&C switch whilst in situ. Removing the need to disturb the HV Cables and increase the risk of future HV Cable Fault.

Process includes all OEM Service Pack components/parts (see Section 5) and includes any current recommended Service Upgrade i.e. F/Sw Fixed Contacts Fuse Clips, Dash Pots, Trip Arm Assy (contact LCL for information regarding any of these).



Section 2 – UpRate Short Time Rating

- Older J3 and T3GF3 units only have a Short Time (3-Sec) Current Rating of 13.1kA.
- Later J4 and T4GF3 units had stronger Contacts & Blades to be certified to 21.9kA (BS2631).
- Long Controls have evolved a Kit of Parts that UpRates J3 and T3GF3 to a KEMA certified 20kA (IEC) 3-Sec Rating.
- UpRate Site in-situ process includes the same as the Fully Invasive Refurbishment.
- Rendering the c. 1970/80's unit fully rated, fully Refurbished to provide another 20-years+ service.
